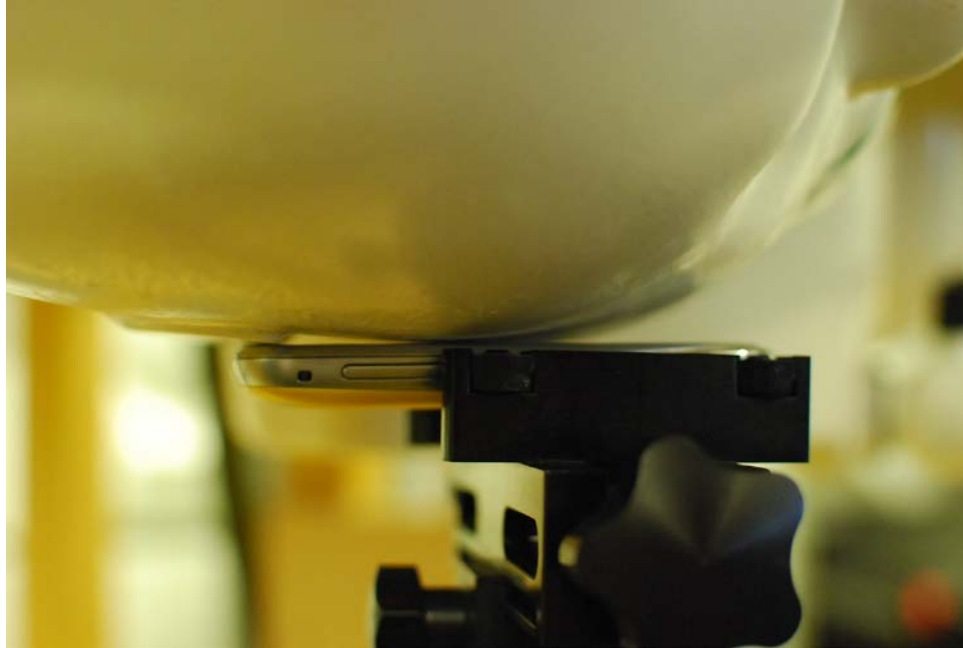
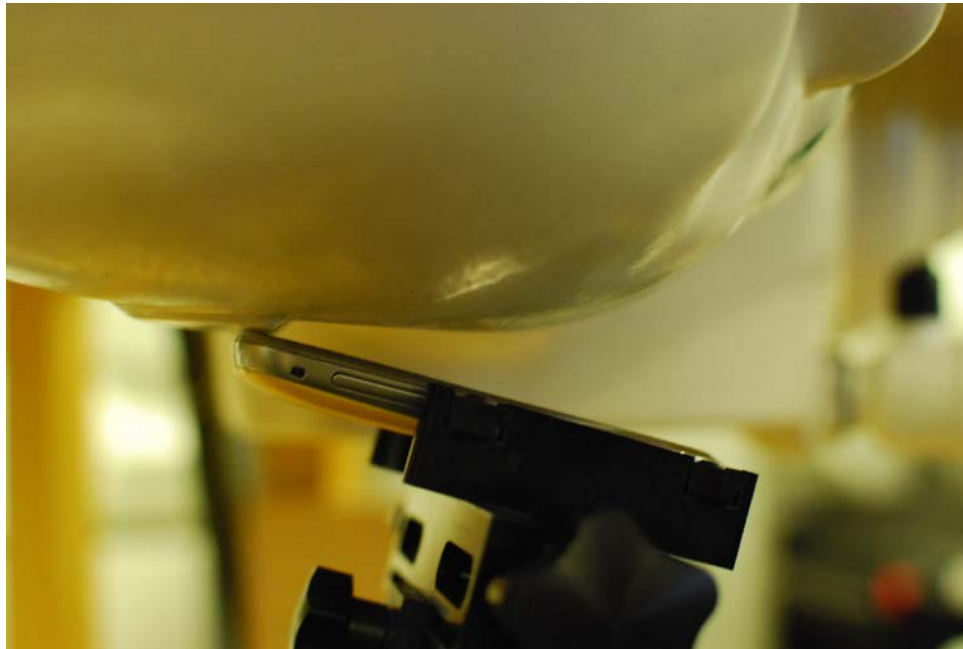

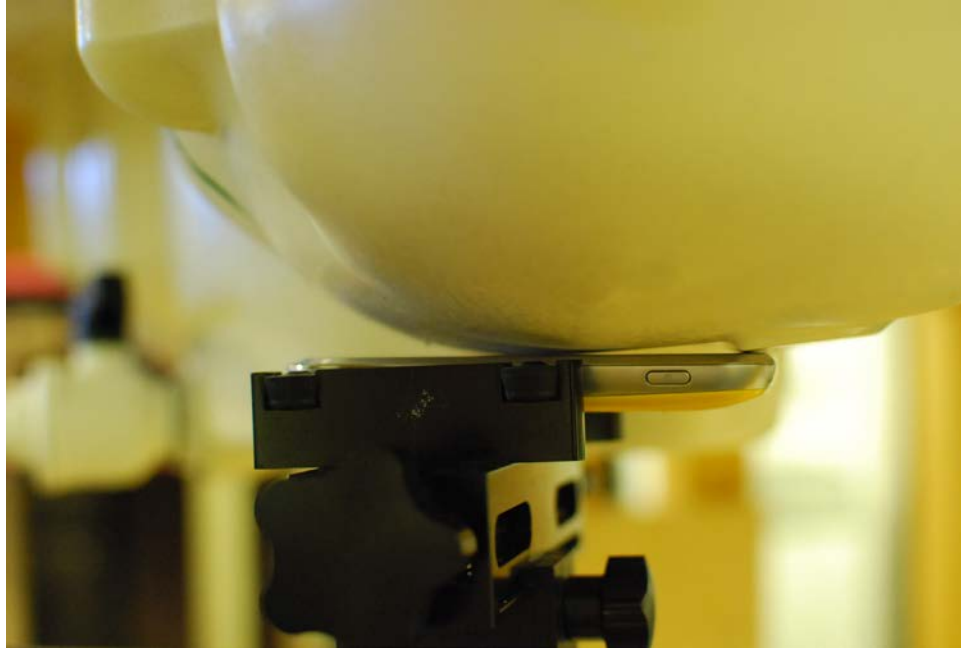


SAR Test Setup Photo 1 – Right Touch

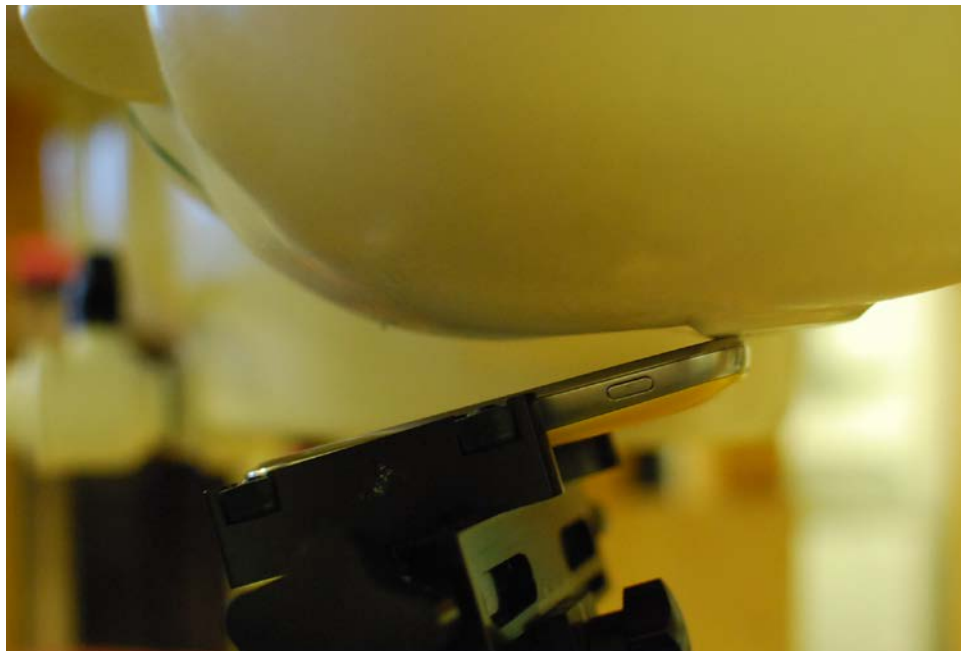


SAR Test Setup Photo 2 – Right Tilt

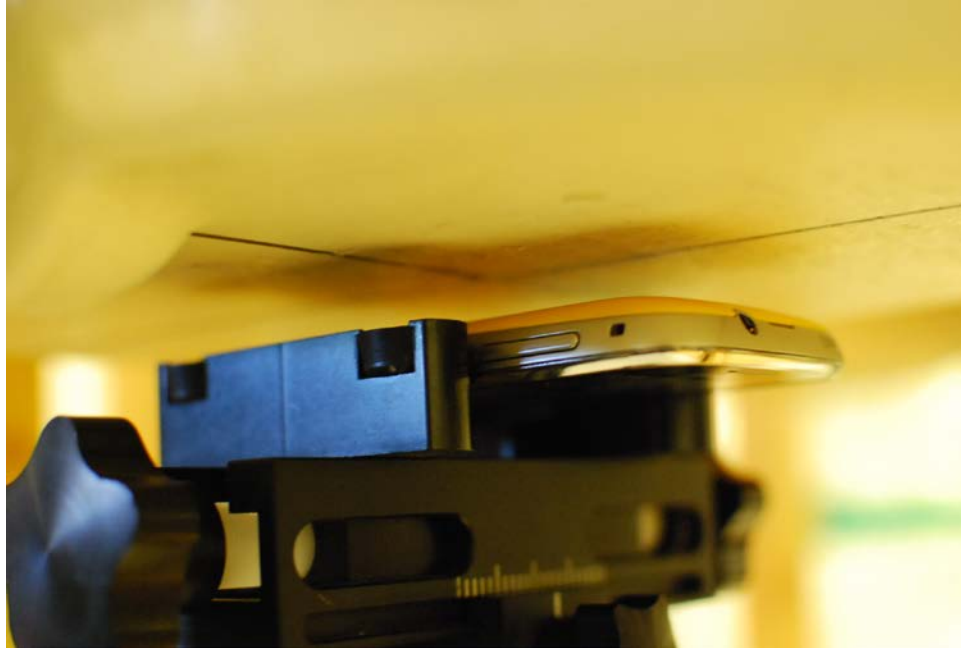


SAR Test Setup Photo 3 – Left Touch

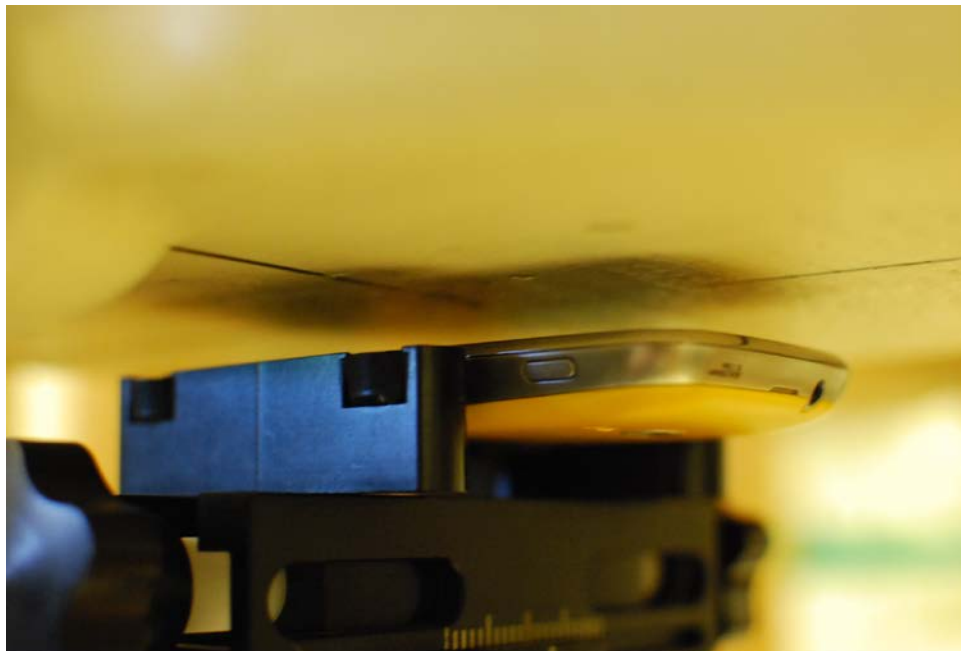


SAR Test Setup Photo 4 – Left Tilt

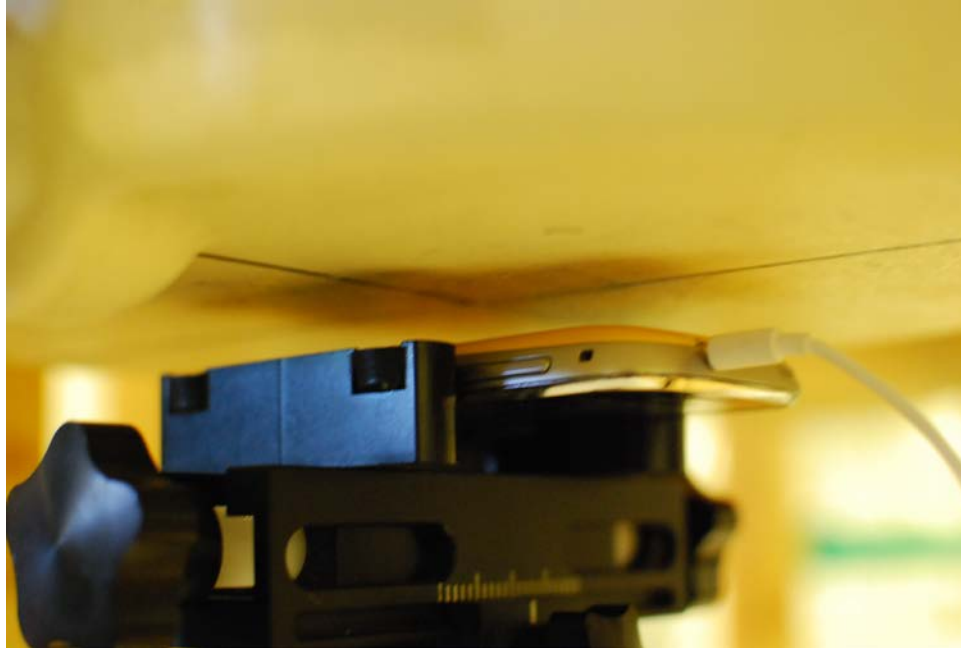


SAR Test Setup Photo 9 – Right at 1.0 cm
