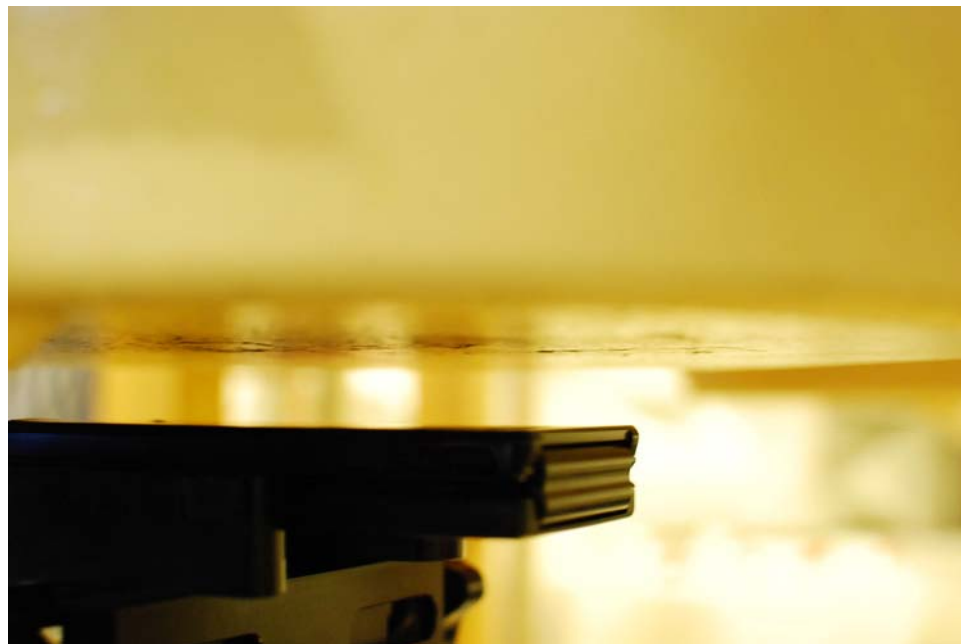

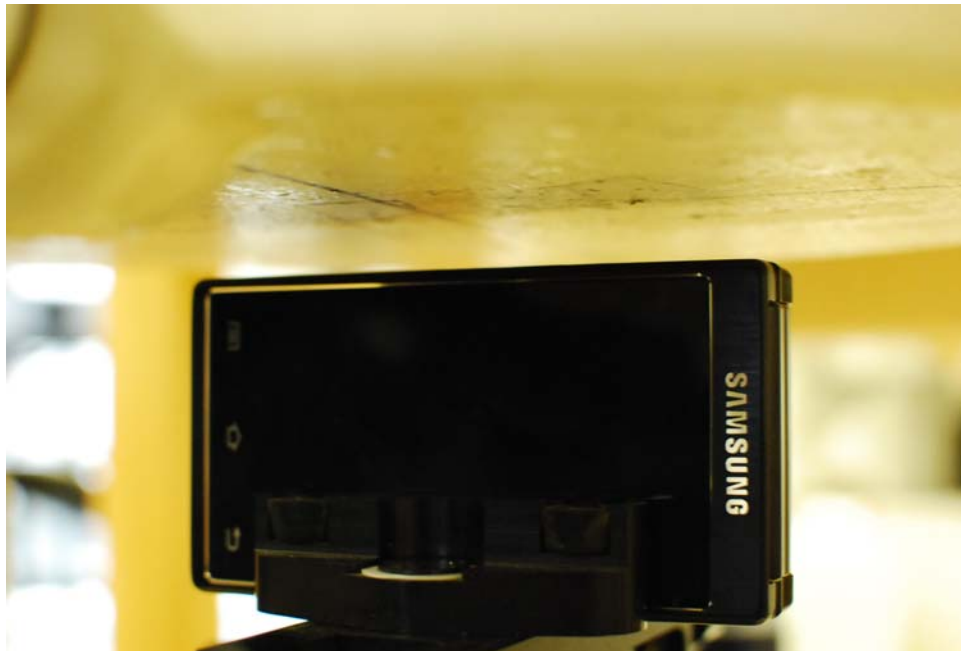


SAR Test Setup Photo 8 – Bottom at 1.0 cm
