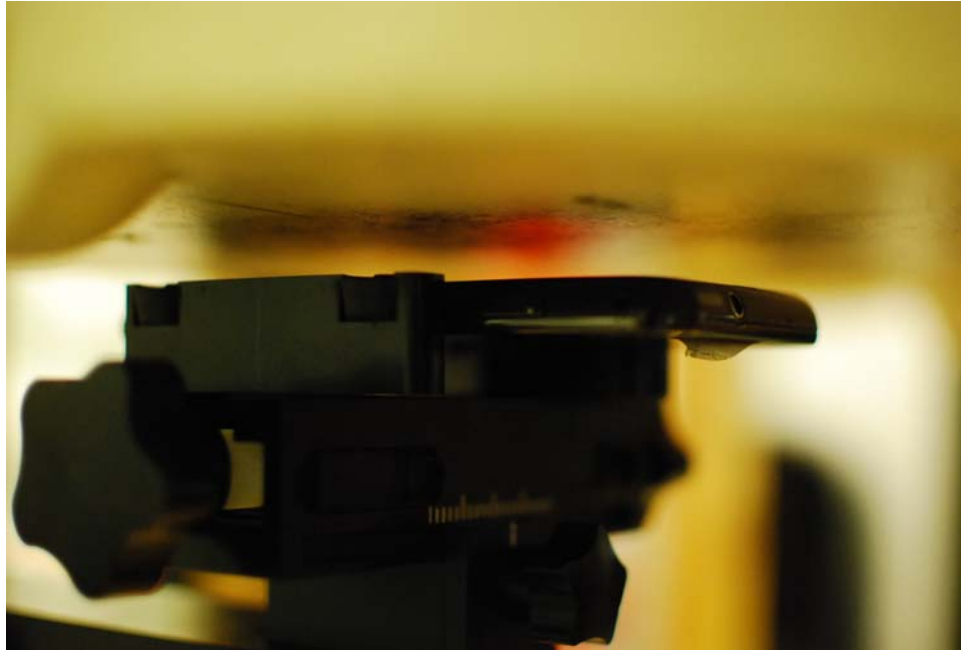


SAR Test Setup Photo 3 – Left Touch

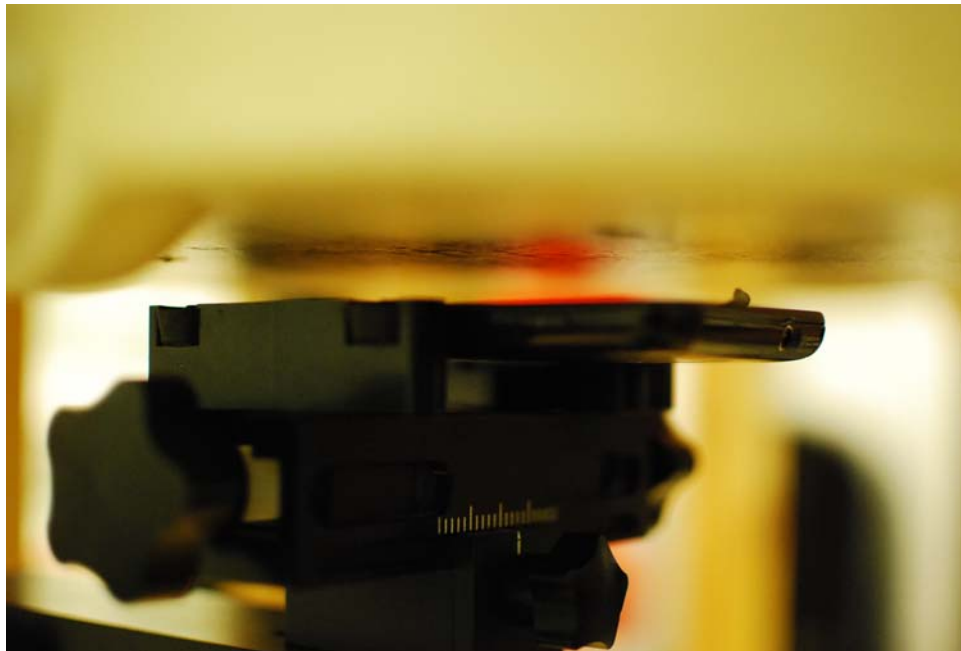


SAR Test Setup Photo 4 – Left Tilt

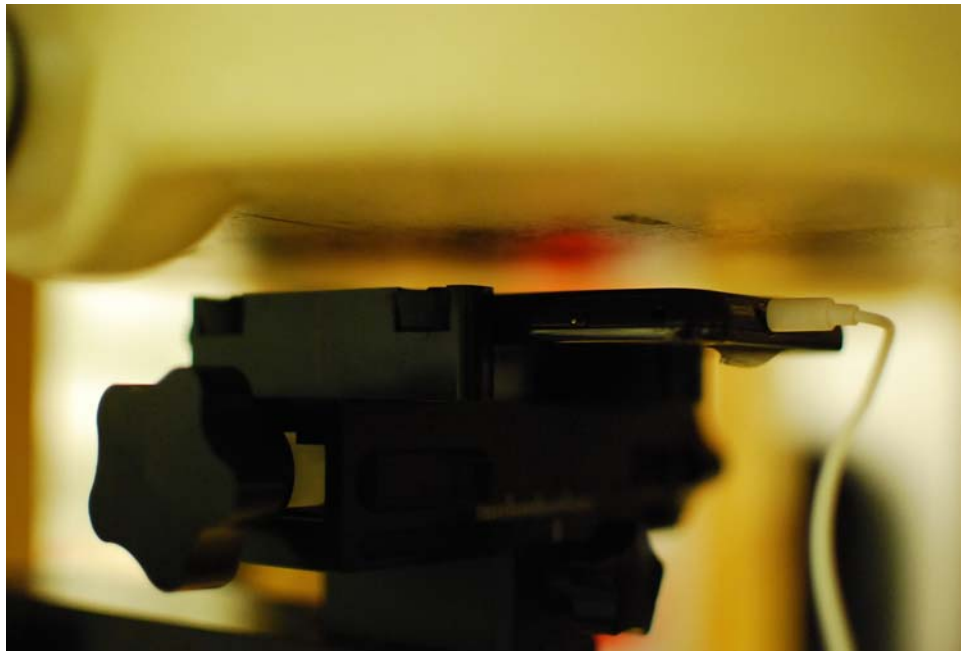


SAR Test Setup Photo 8 – Right at 1.0 cm
