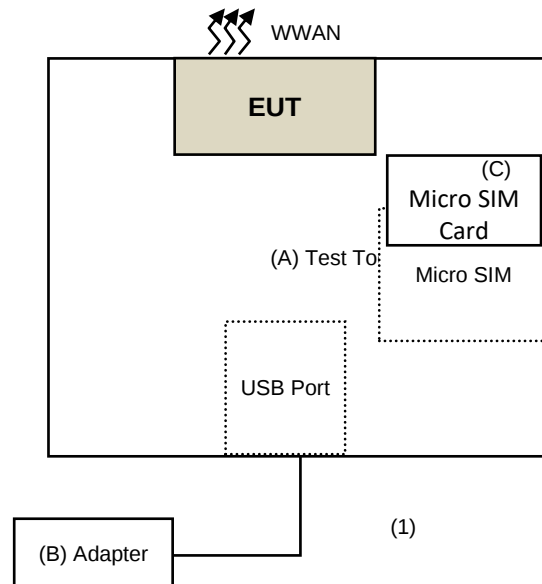

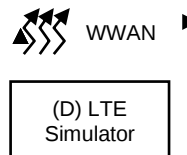

4 Test Types and Results

4.1 Output Power Measurement

4.1.1 Limits of Output Power Measurement and Antenna Height

According to 90.635 (b), Maximum output power of the transmitter for mobile stations is 100 watts (20 dBw). According to 90.542(a)(7), Portable stations (hand-held devices) transmitting in the 758-768 MHz band and the 788-798 MHz band are limited to 3 watts ERP.

4.1.2 Test Procedures

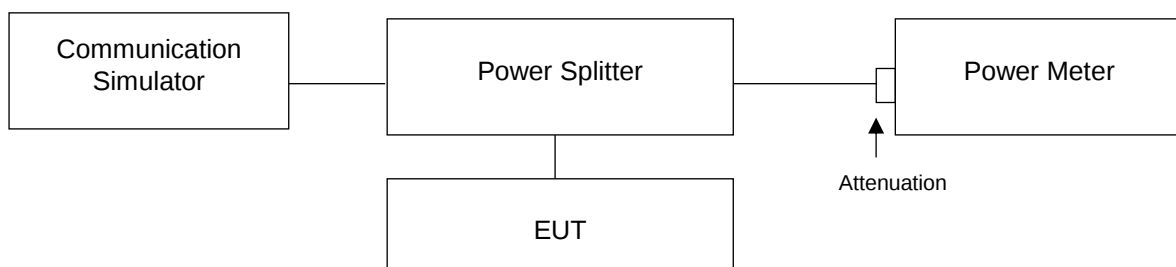
Conducted Power Measurement:

The EUT was set up for the maximum power with LTE link data modulation and link up with simulator. Set the EUT to transmit under low, middle and high channel and difference RB size/ RB offset for difference bandwidth record the power level shown on power meter.

EIRP / ERP Measurement:

- EIRP = Conducted Output power level + Antenna gain.
- ERP power can be calculated form EIRP power by subtracting the gain of dipole, ERP power = EIPR power - 2.15dBi.
- ERP = Conducted Output power level + Antenna gain (dBi) - Isotropically Factor (2.15dB).

4.2 Radiated Emission Measurement

4.2.1 Limits of Radiated Emission Measurement

The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least $43 + 10 \log_{10}(P)$ dB. The limit of emission equal to -13dBm

For operations in the 758-775 MHz and 788-805 MHz bands, all emissions including harmonics in the band 1559-1610 MHz shall be limited to -70 dBW/MHz equivalent isotropically radiated power (EIRP) for wideband signals.

4.2.2 Test Procedure

- Substitution method is used for EIRP measurement. In the semi-anechoic chamber, EUT placed on the 0.8m/1.5m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
- Follow ANSI 63.26 section 5.2.7 d), $\text{EIRP Value (dBm)} = \text{Read Value (dB}\mu\text{V/m)} - \text{Correction Factor @ 3m}$
- Correction Factor (dB) @ 3m = $20\log(D) - 104.8$; where D is the measurement distance @3m = -95.26dB
- ERP power can be calculated from EIRP power by subtracting the gain of dipole, $\text{ERP power} = \text{EIRP power} - 2.15\text{dBi}$.

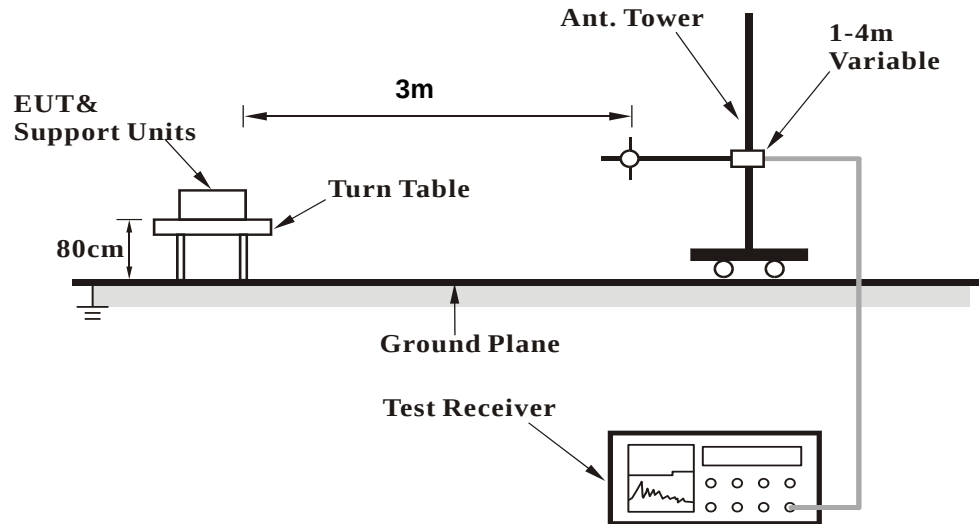

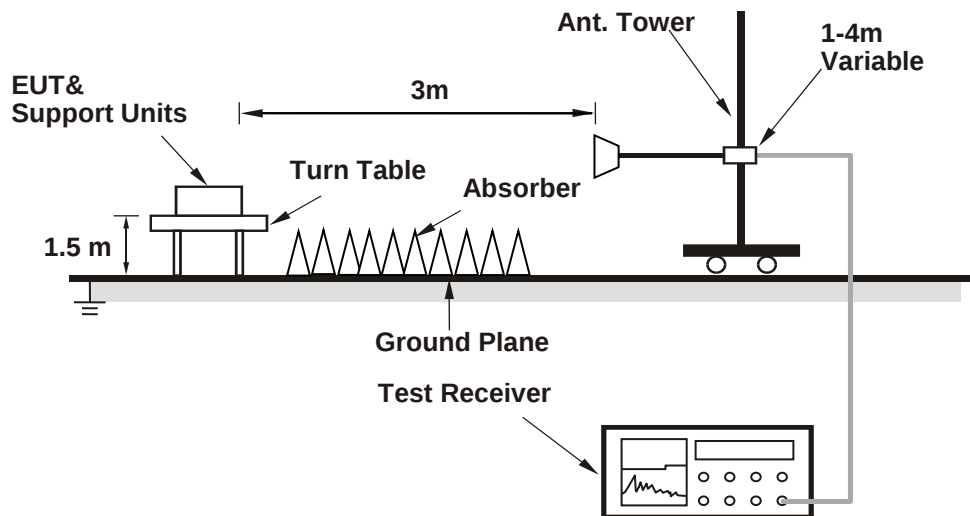
