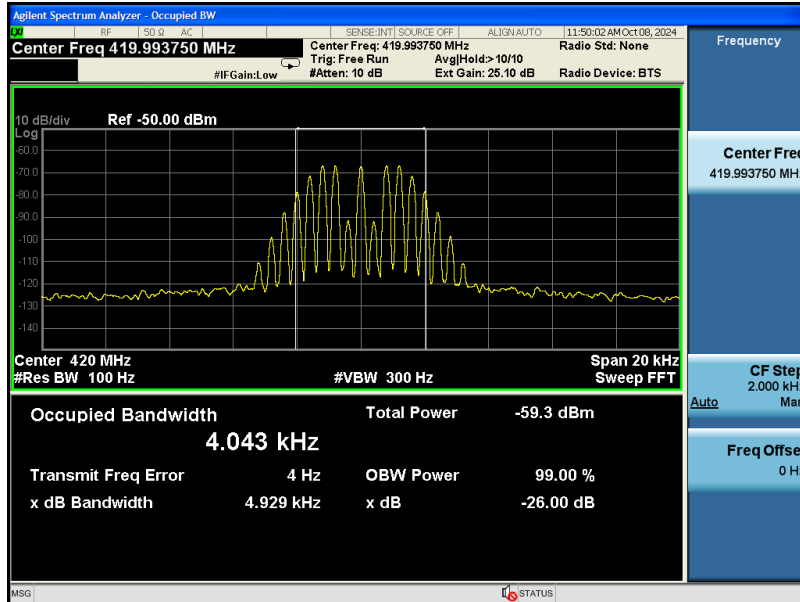


DL_FM_MCH_Output_3dB above AGC

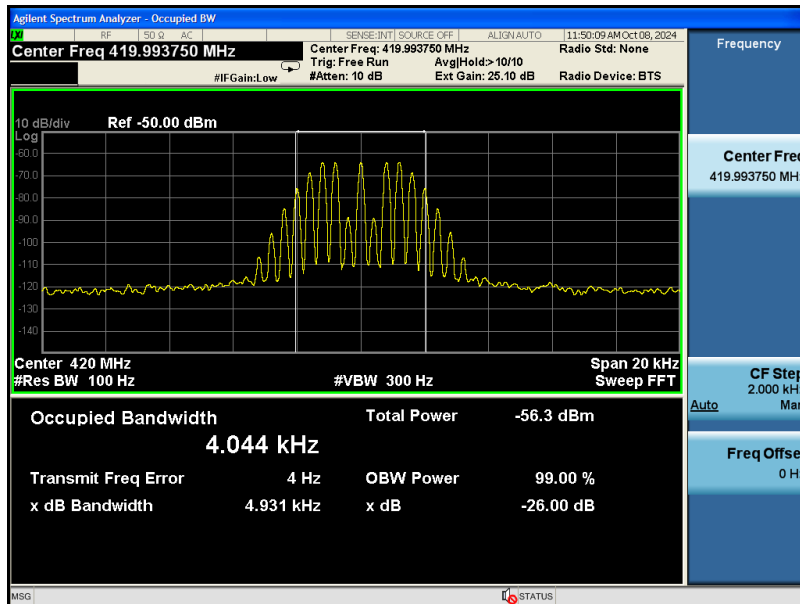

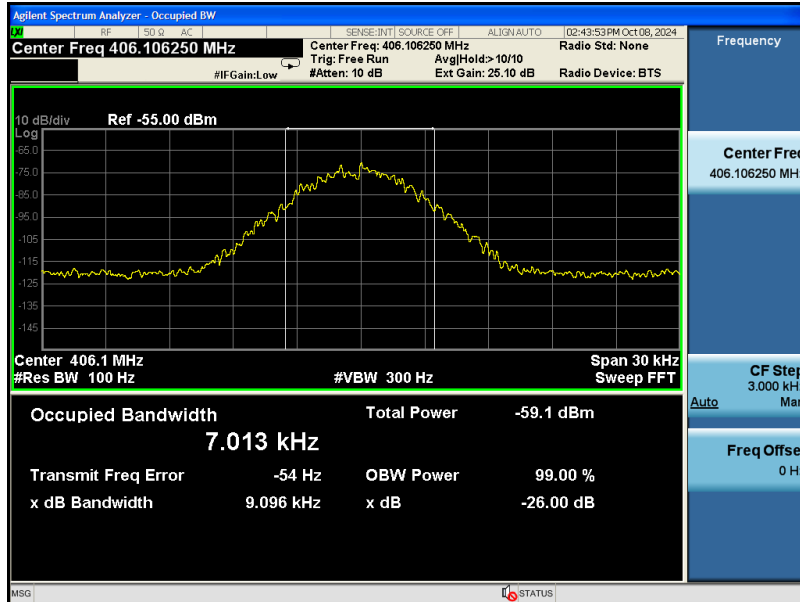


DL_FM_HCH_Output_3dB above AGC

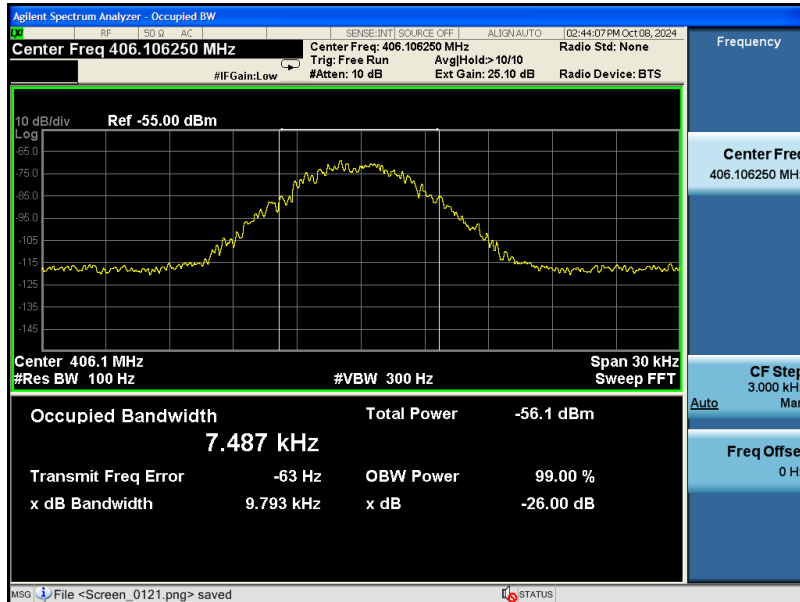

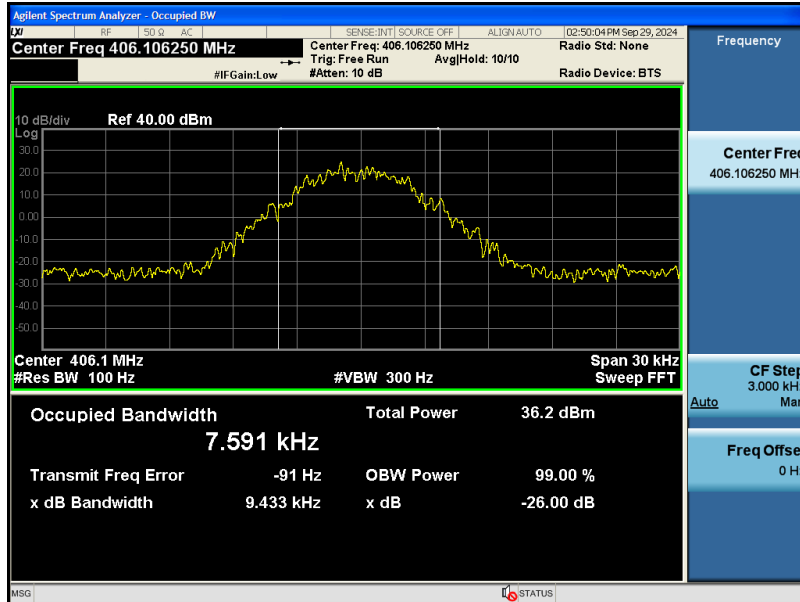


DL_DMR_LCH_Input_3dB above AGC

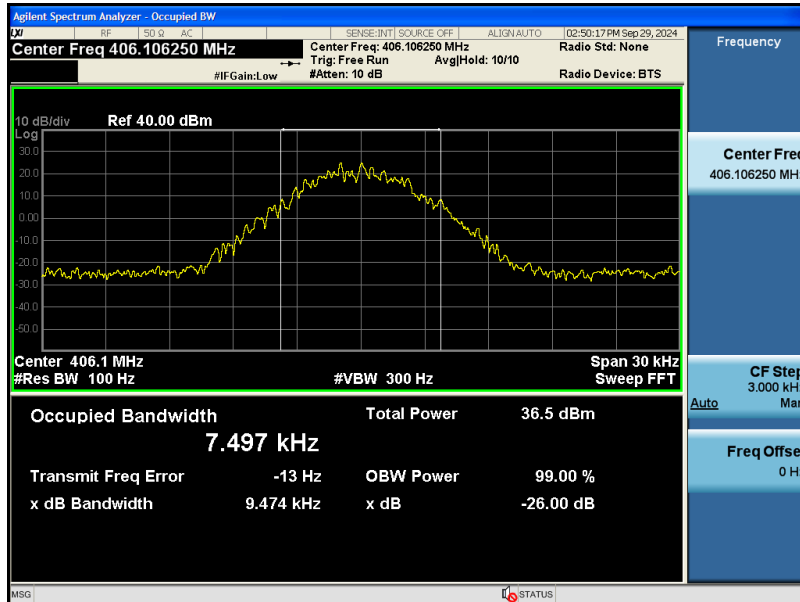

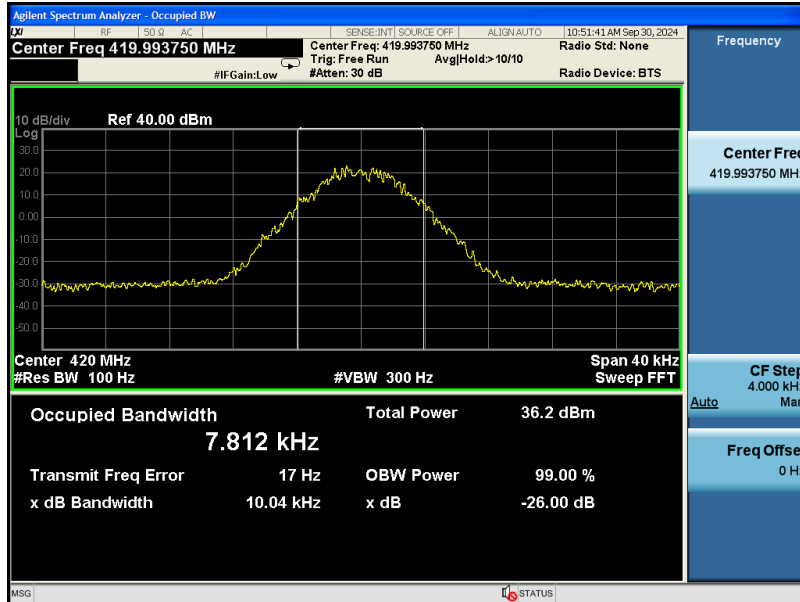

DL_H-DQPSK_LCH_Input_Pre-AGC

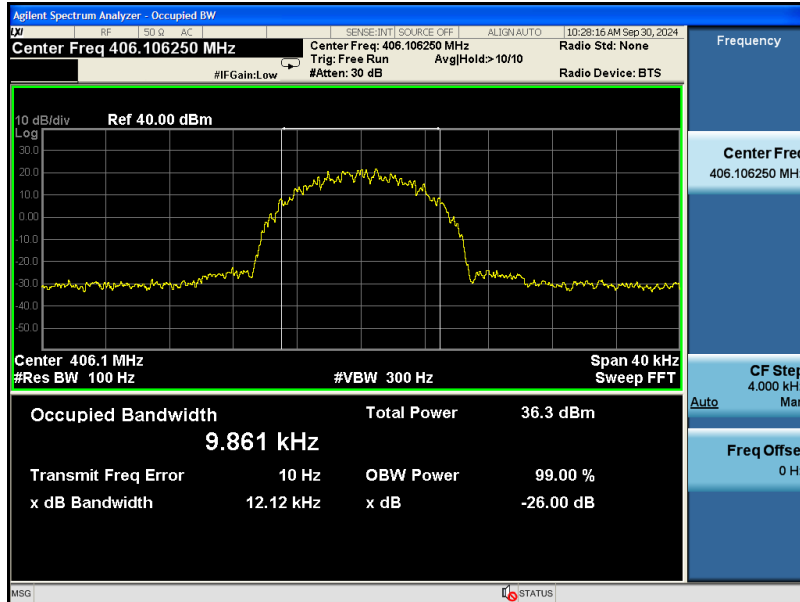


DL_H-DQPSK_LCH_Input_3dB above AGC

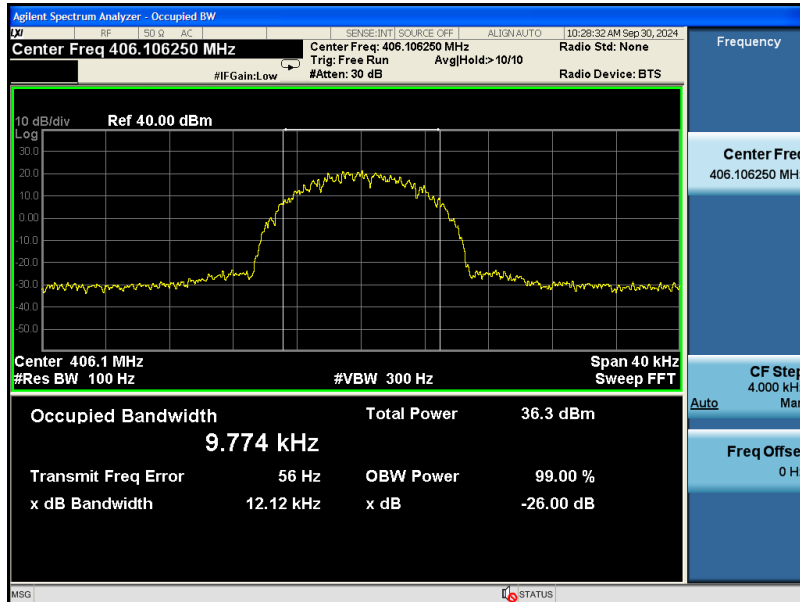

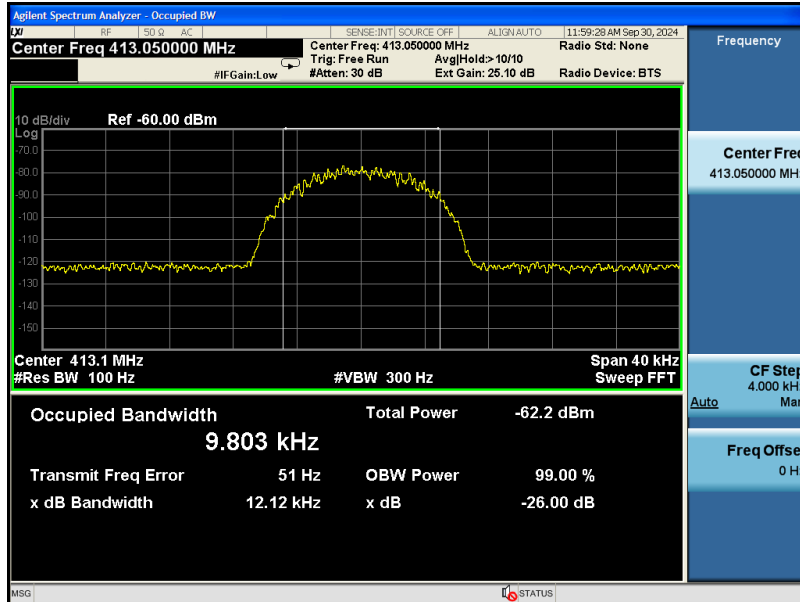


DL_H-DQPSK_LCH_Output_3dB above AGC

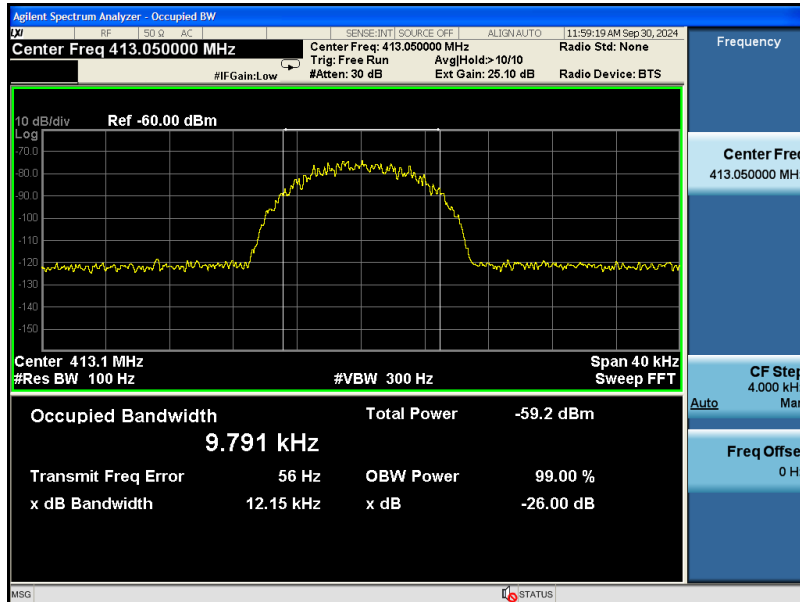

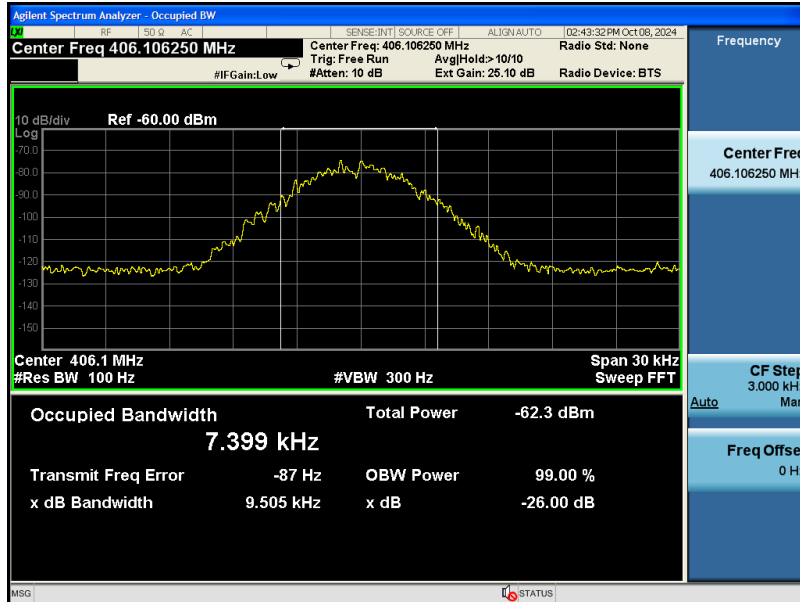


UL_FM_HCH_Output_3dB above AGC

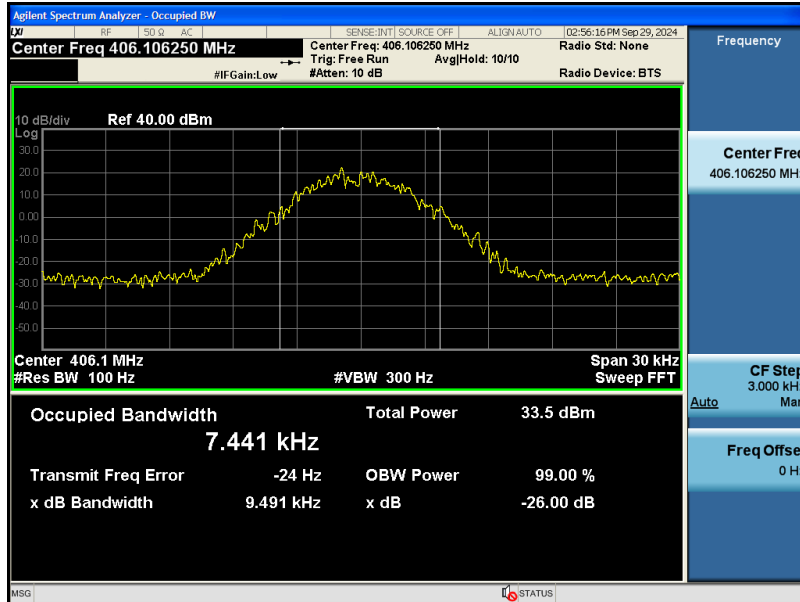

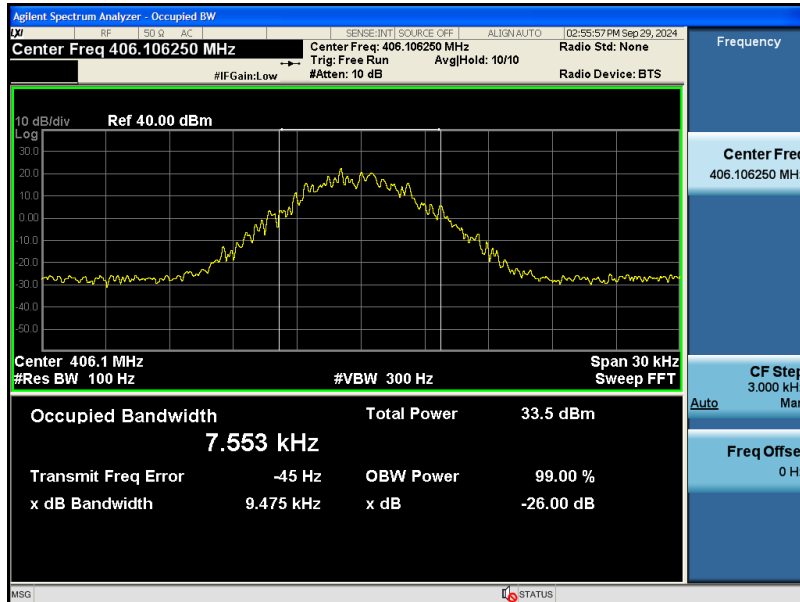

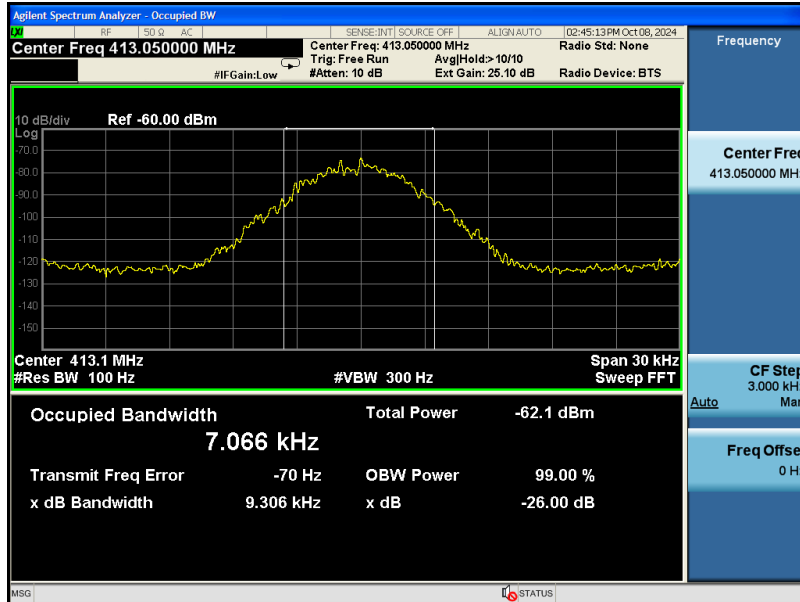


UL_DMR_LCH_Output_3dB above AGC

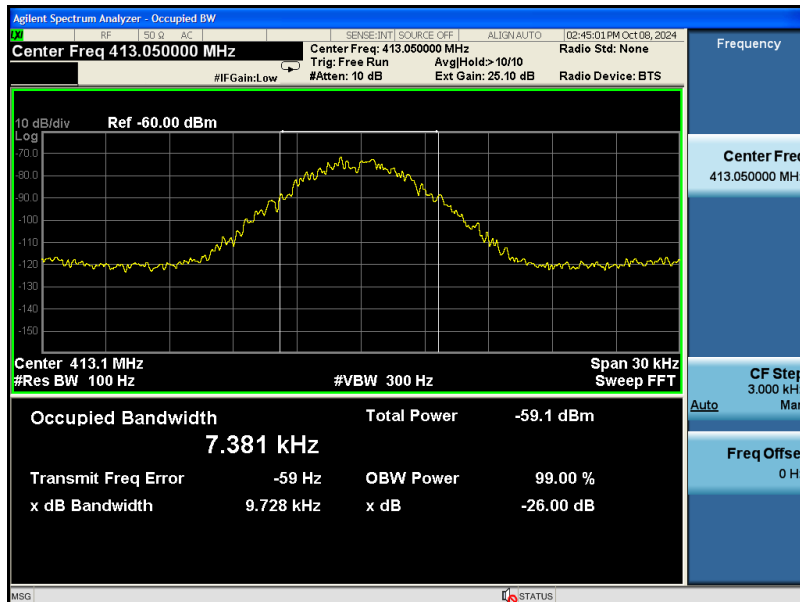

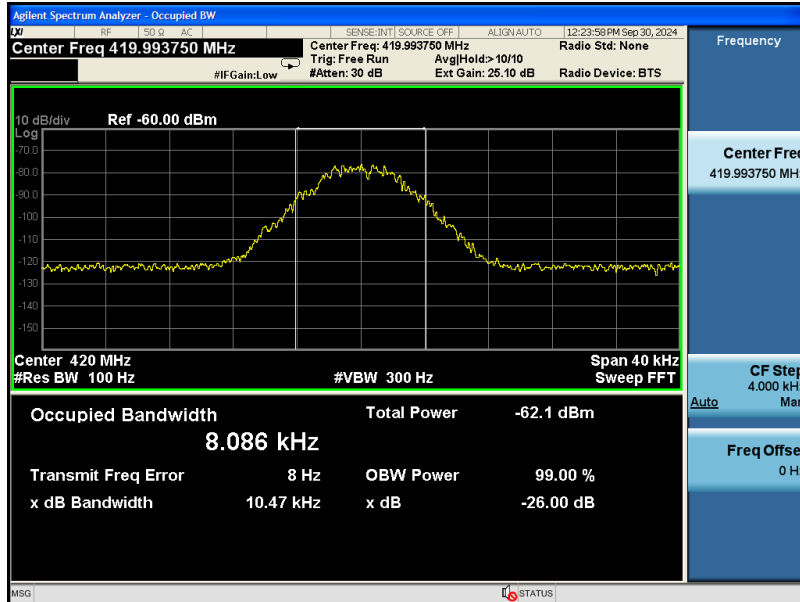


UL_C4FM_MCH_Output_3dB above AGC

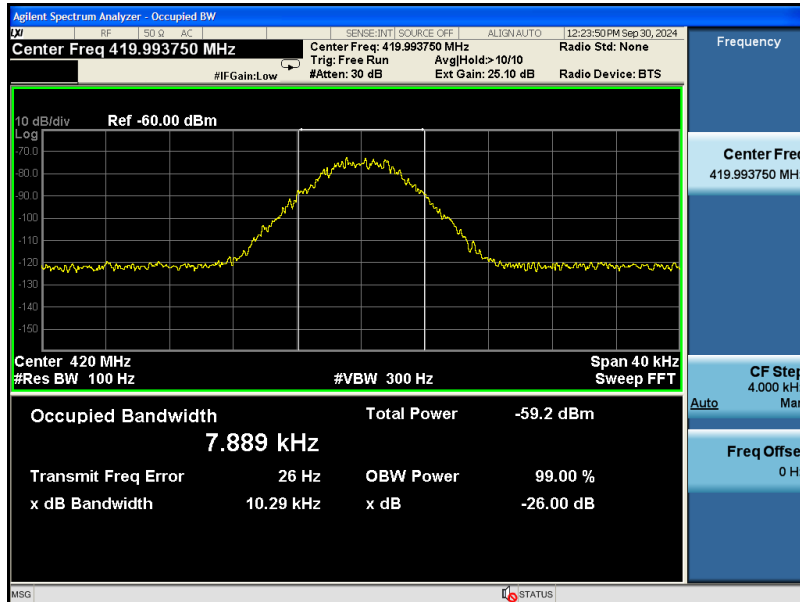

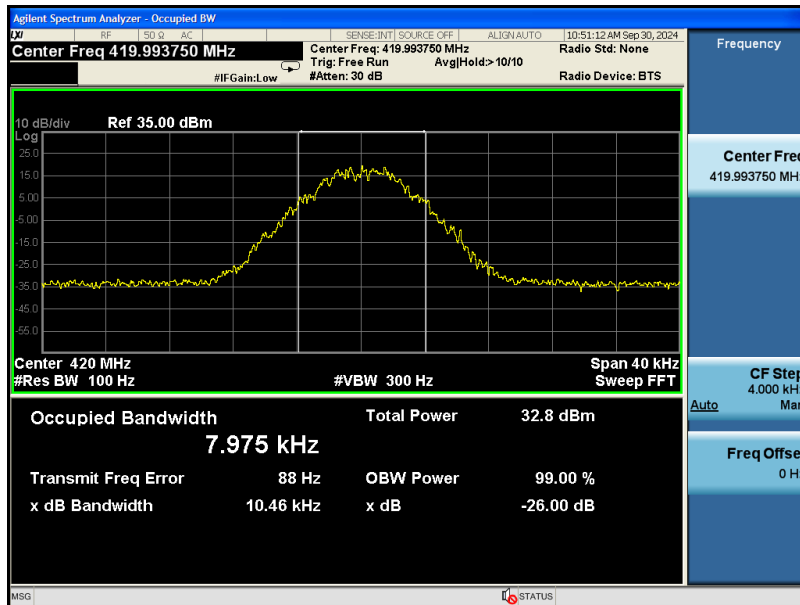


UL_C4FM_HCH_Input_3dB above AGC

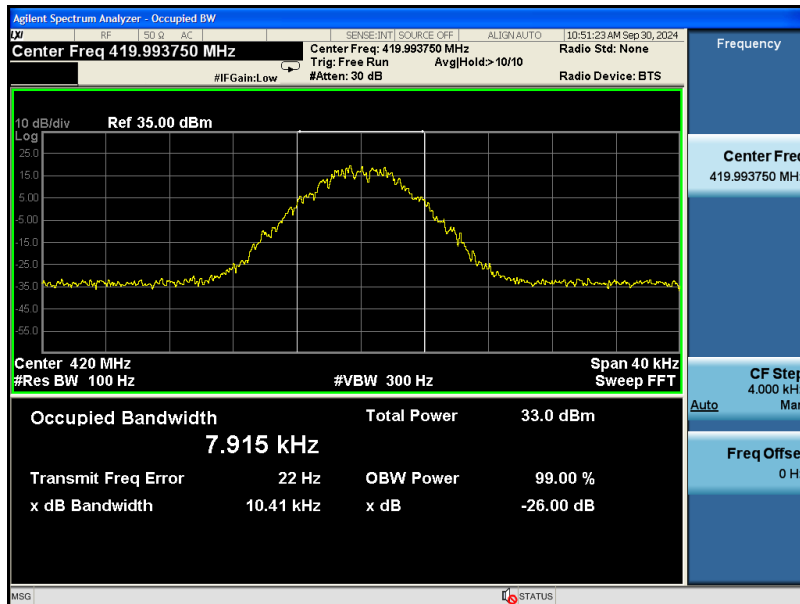

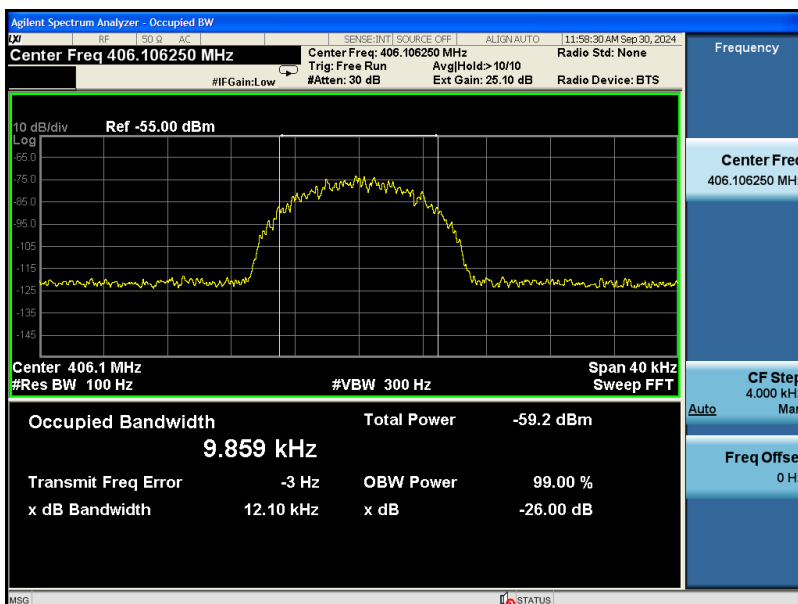


UL_C4FM_HCH_Output_3dB above AGC

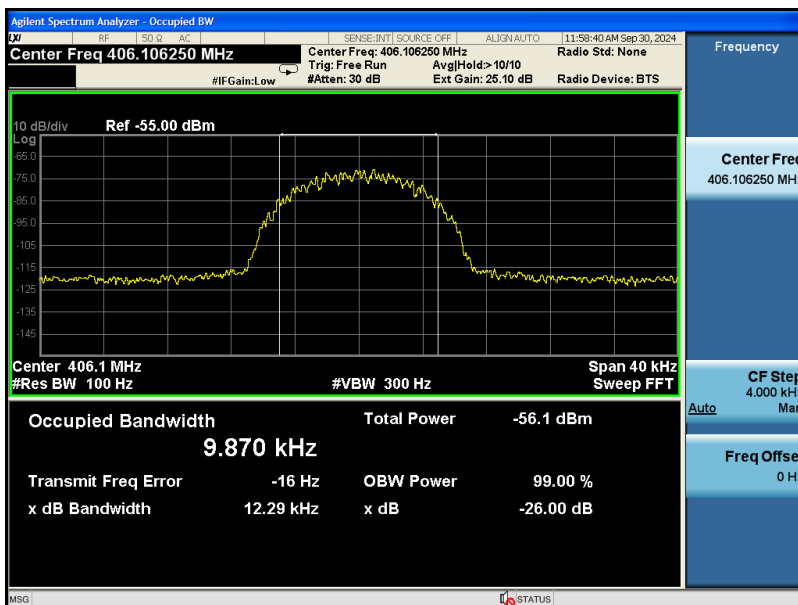

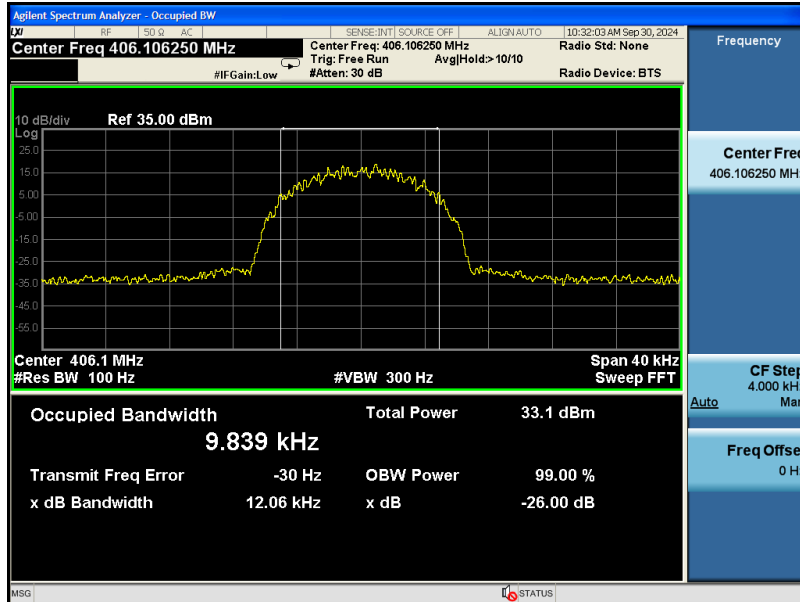


UL_H-DQPSK_LCH_Input_3dB above AGC

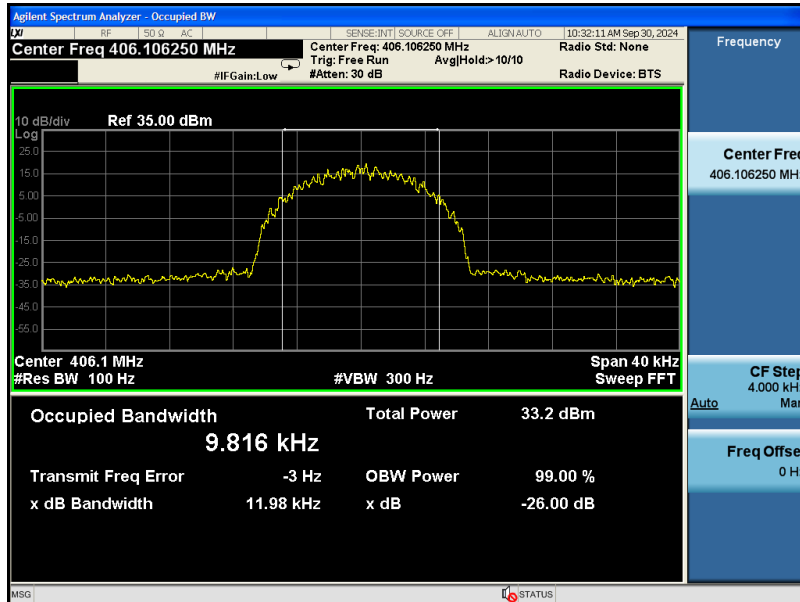

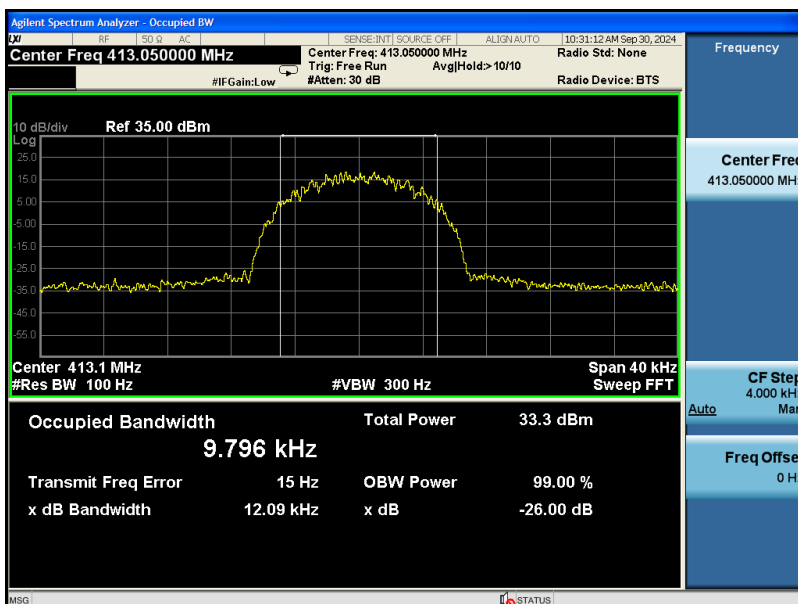


UL_H-DQPSK_MCH_Input_3dB above AGC

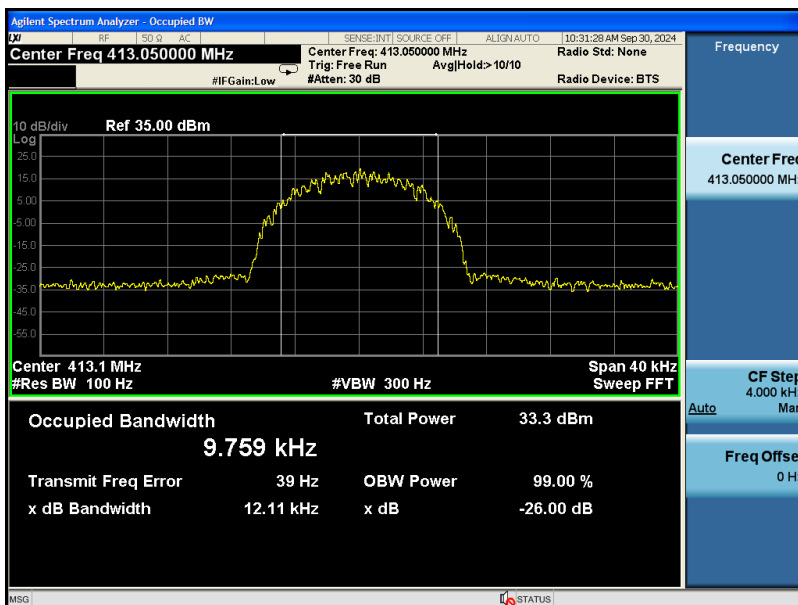

UL_H-DQPSK_MCH_Output_Pre-AGC

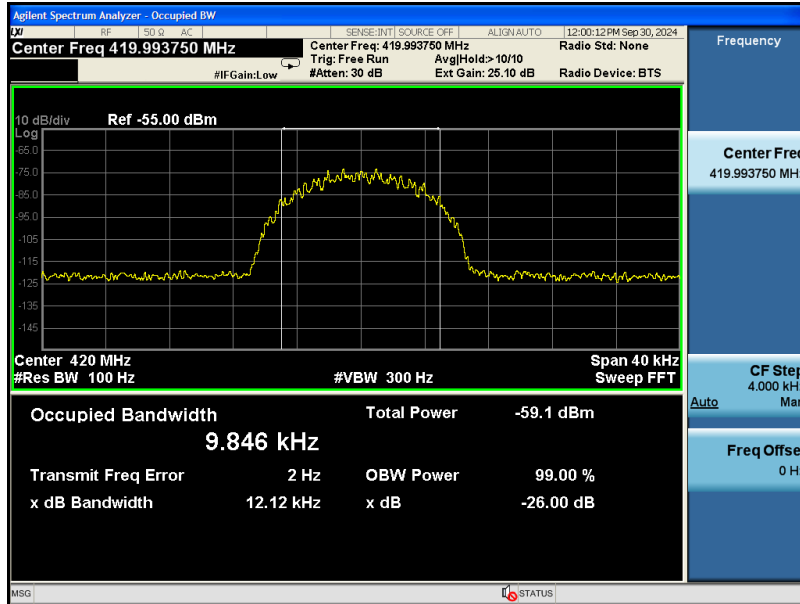


UL_H-DQPSK_MCH_Output_3dB above AGC

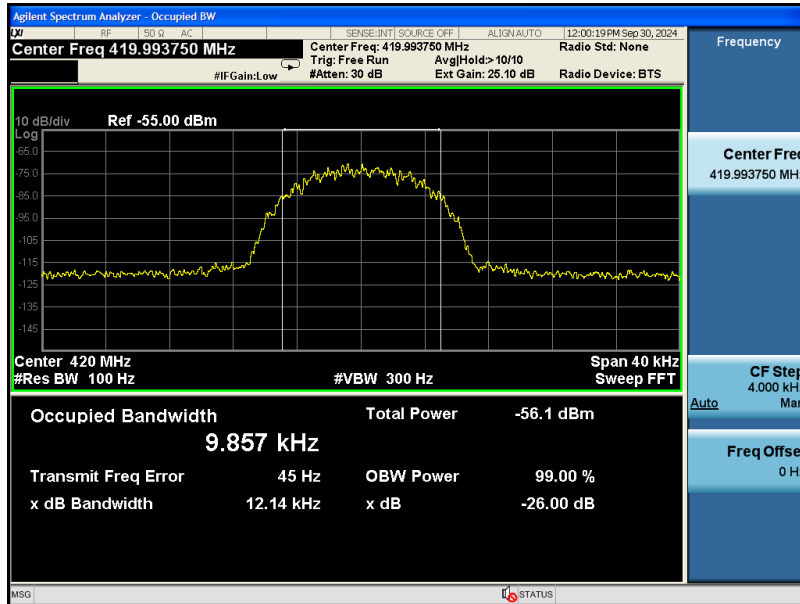

UL_H-DQPSK_HCH_Input_Pre-AGC

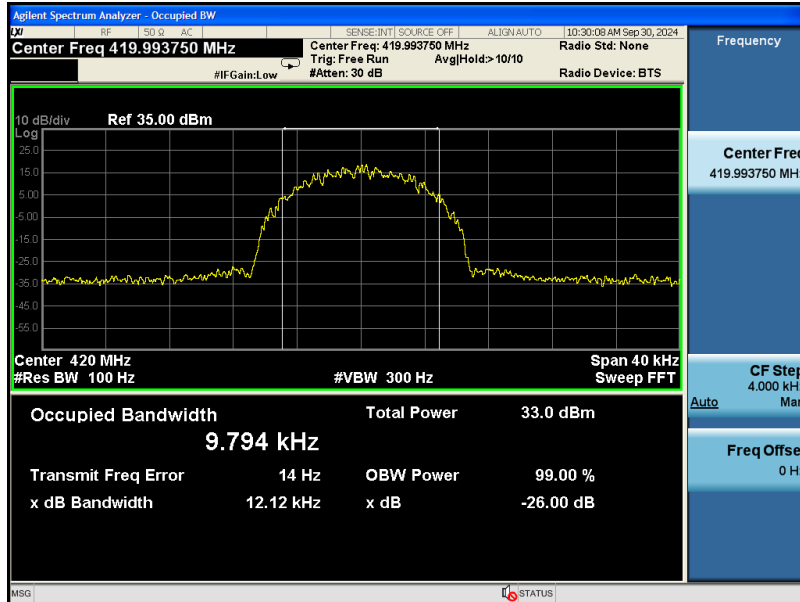


UL_H-DQPSK_HCH_Input_3dB above AGC

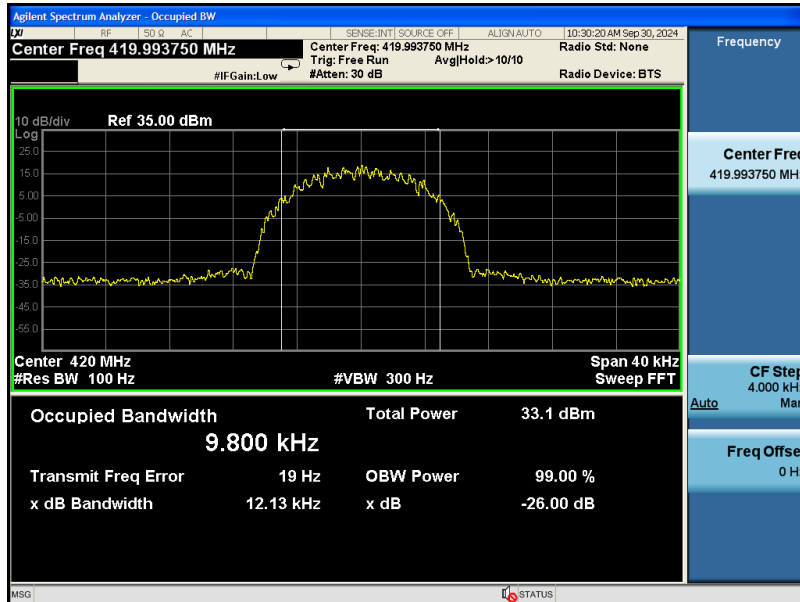

UL_H-DQPSK_HCH_Output_Pre-AGC

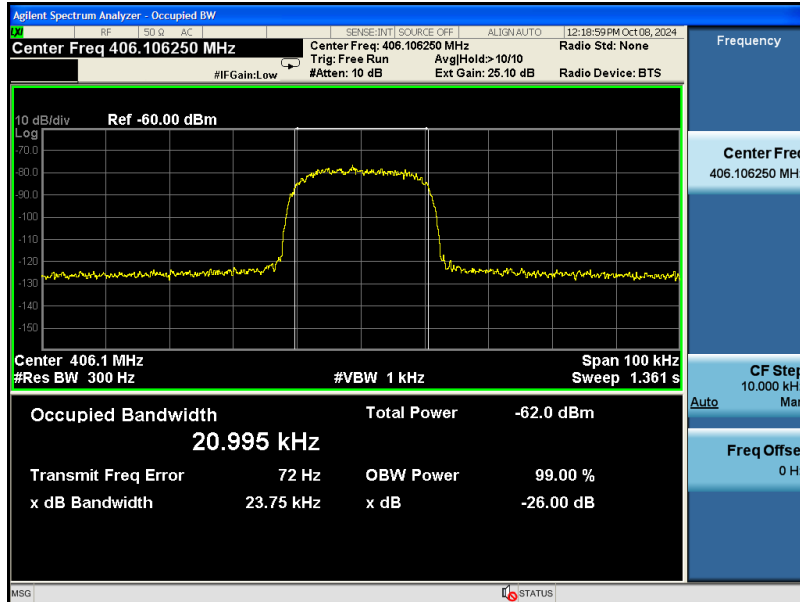


UL_H-DQPSK_HCH_Output_3dB above AGC

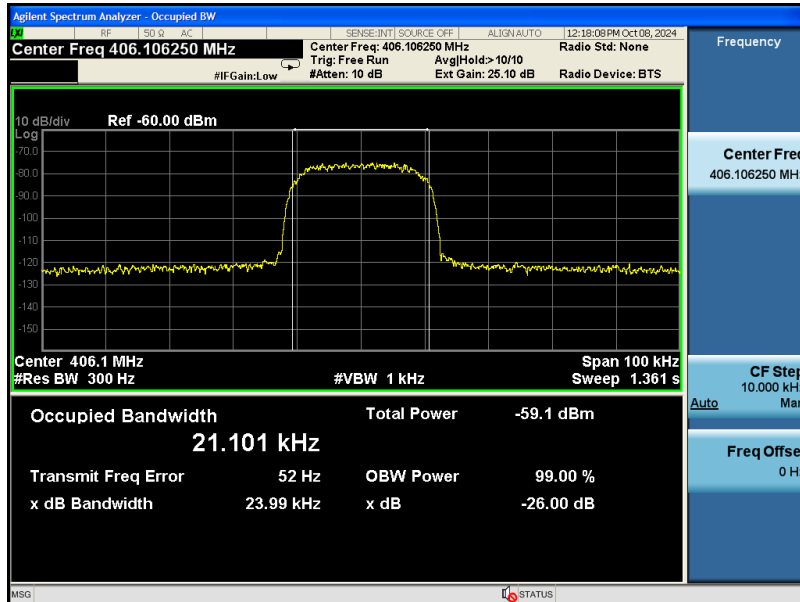

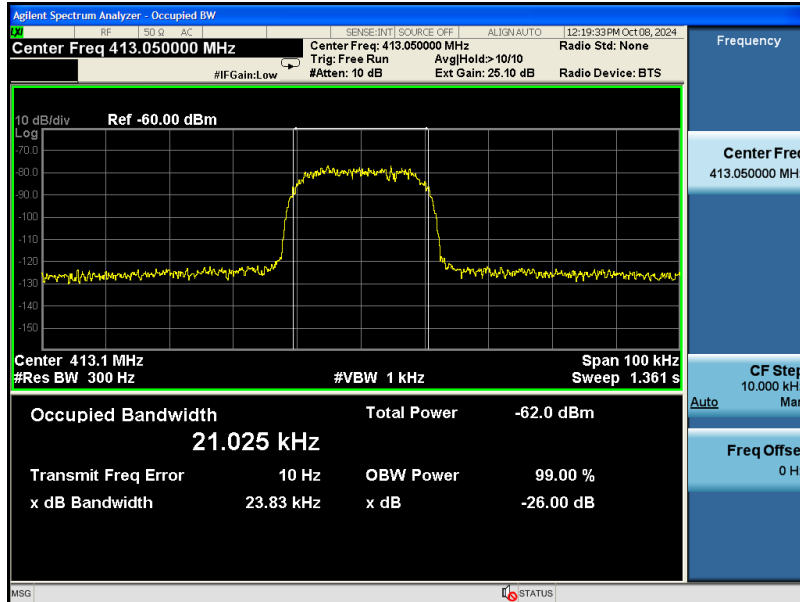


UL_TETRA_LCH_Output_3dB above AGC

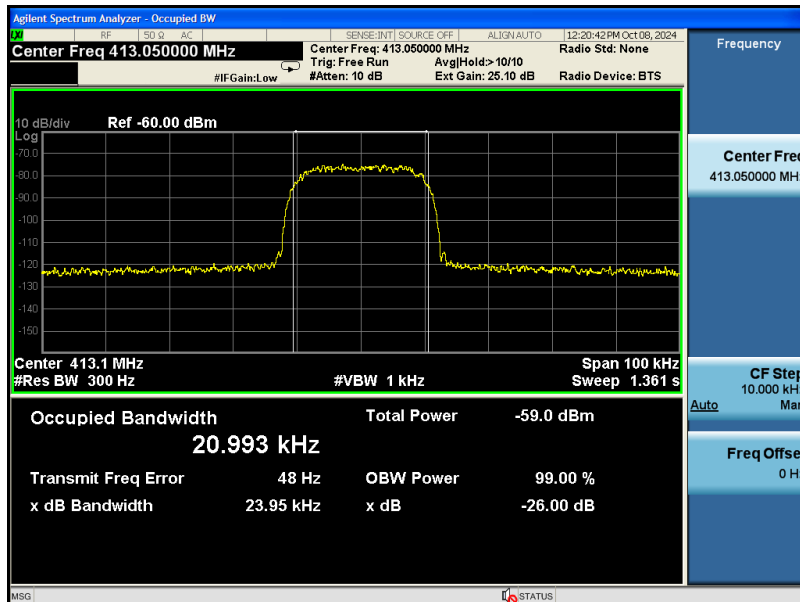

UL_TETRA_MCH_Input_Pre-AGC

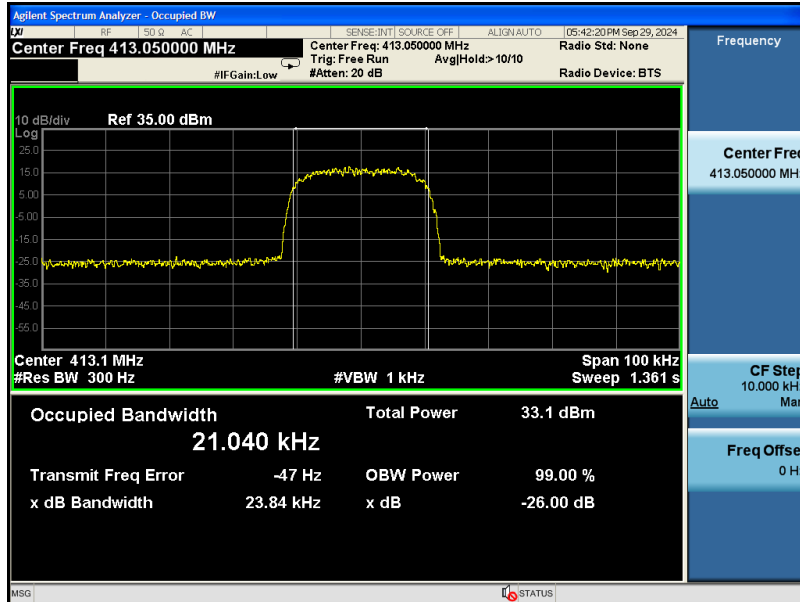


UL_TETRA_MCH_Input_3dB above AGC

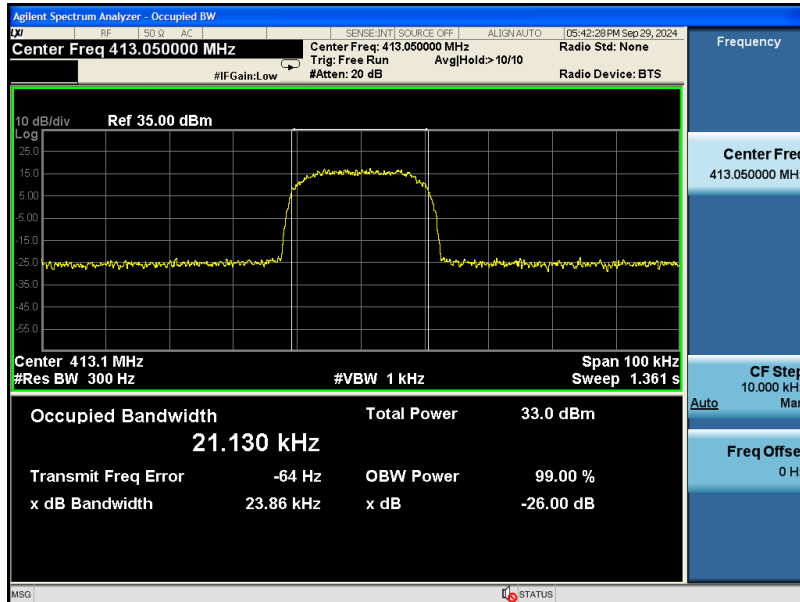

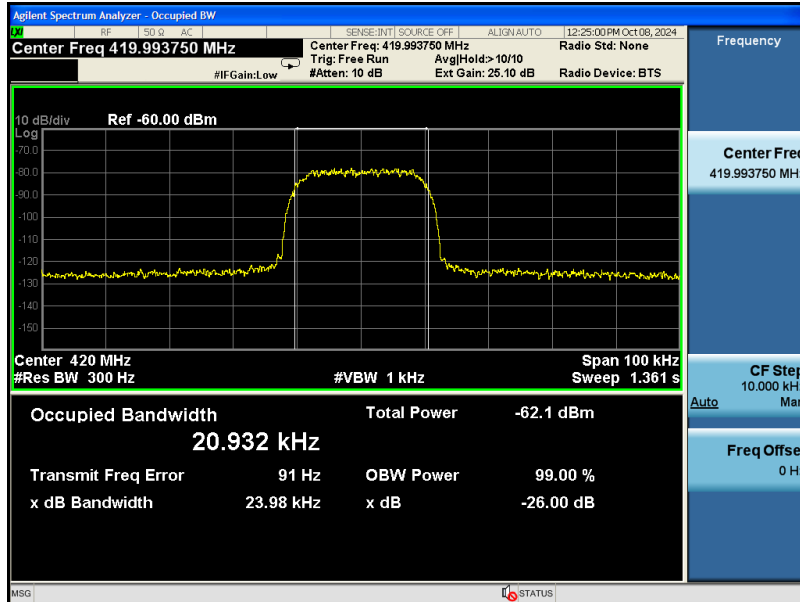


UL_TETRA_MCH_Output_3dB above AGC

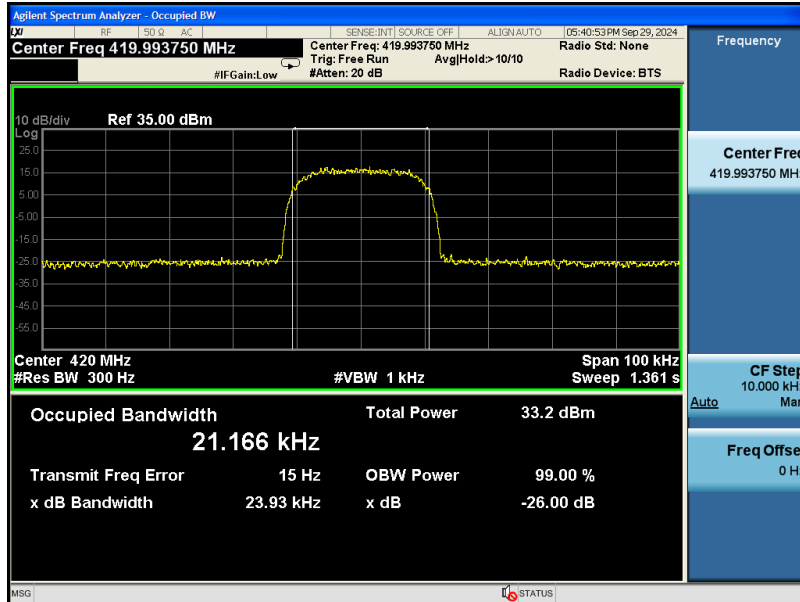


UL_TETRA_HCH_Input_3dB above AGC

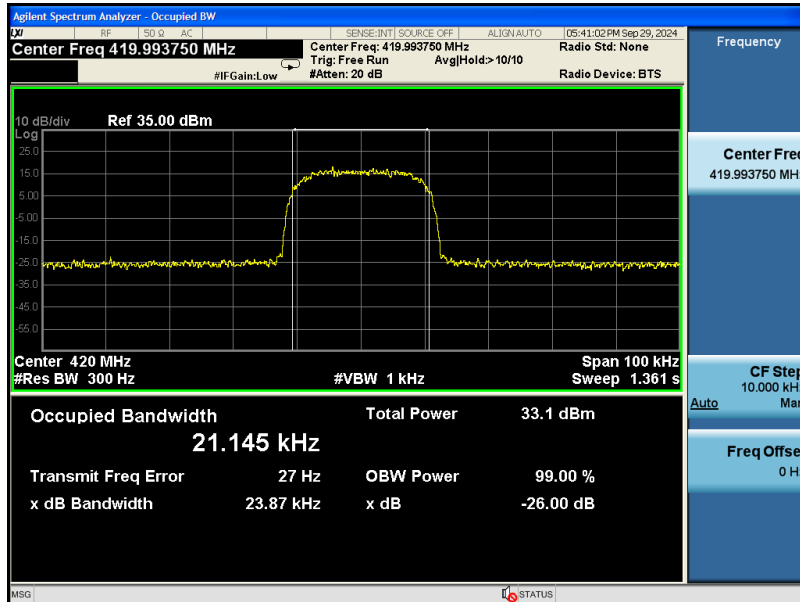
