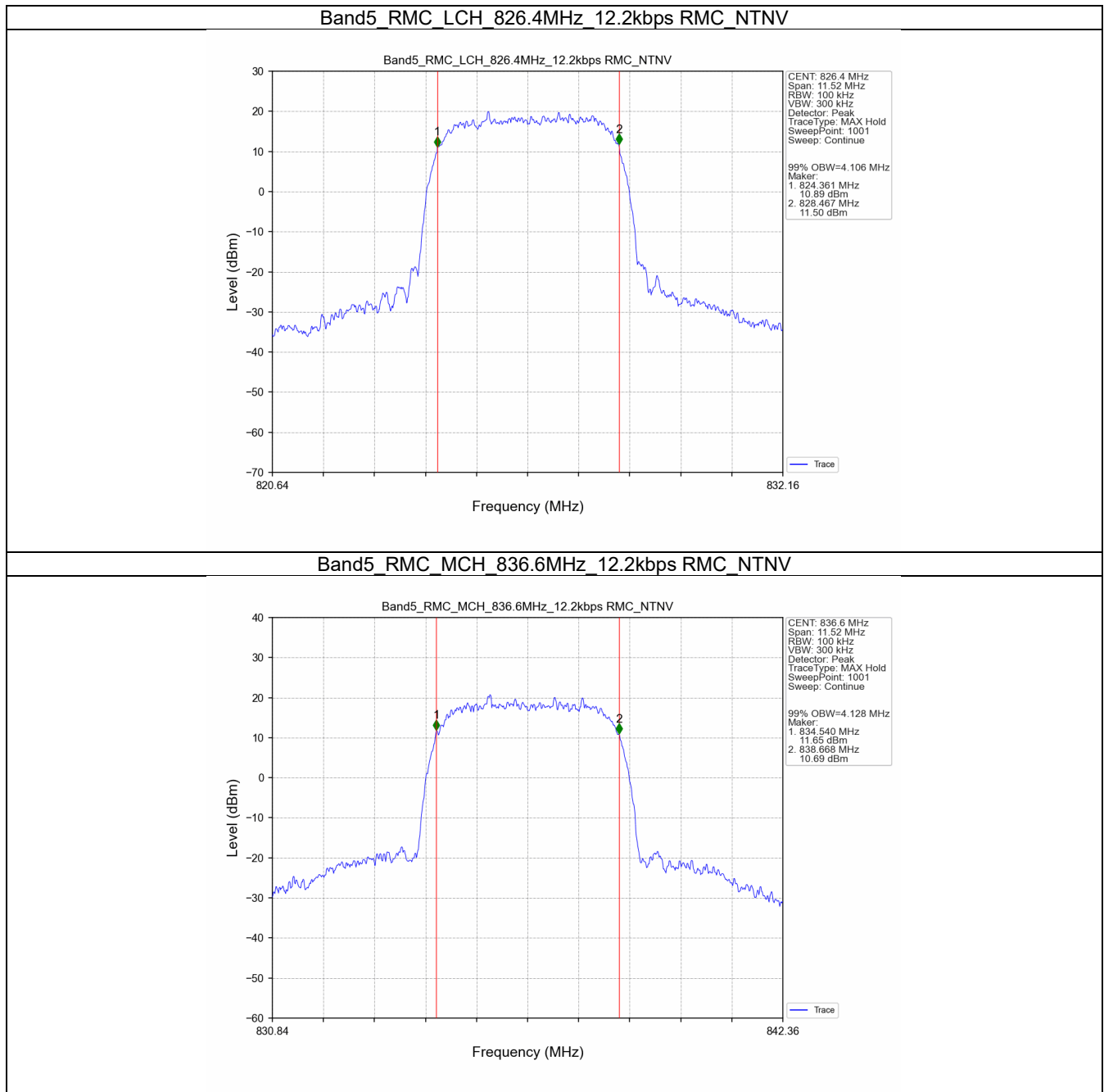

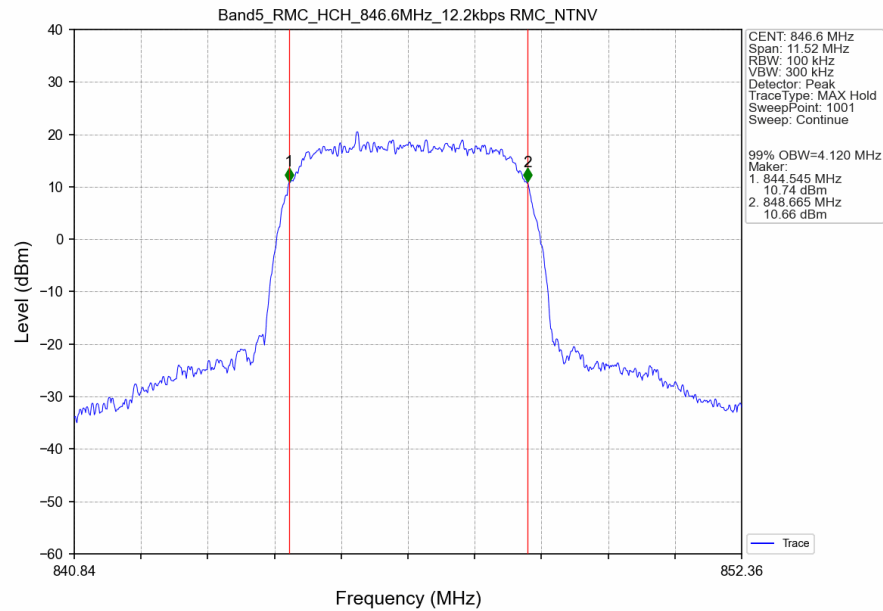

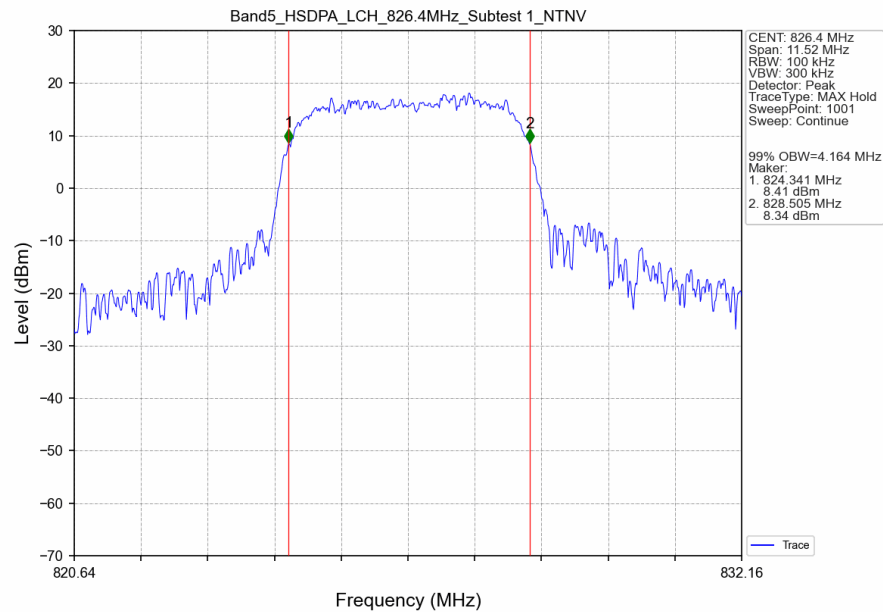

Band5_RMC_HCH_846.6MHz_12.2kbps RMC_NTNV



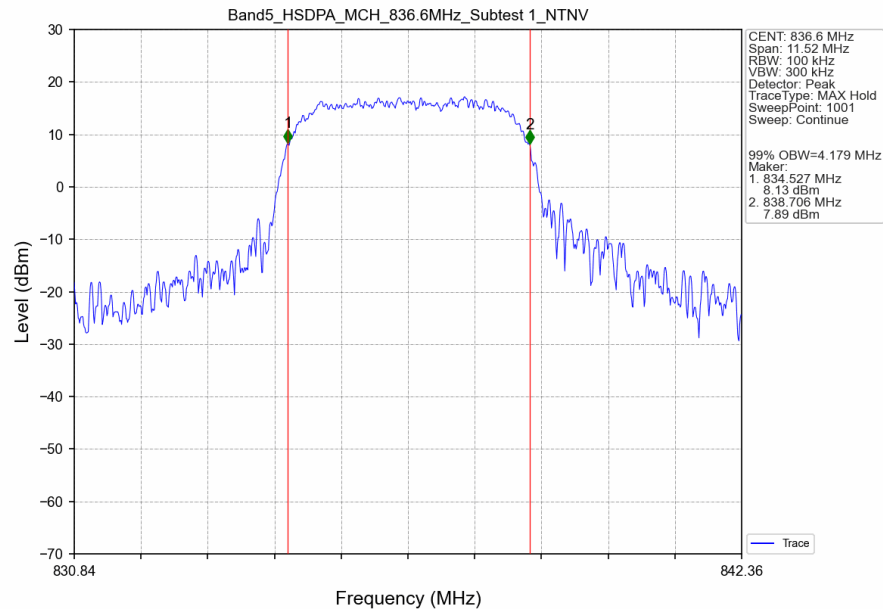
