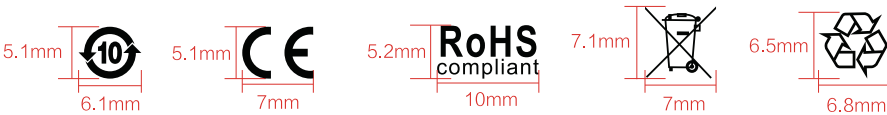

1. The blue LED indicator is on when charging connected.
2. The LED indicator flashes slowly in blue when devices charged.
3. FOD(Foreign object): The LED indicator flashes quickly in blue when unknown object is detected.

Operating Instructions

1. Using the cable provided, connect the 3-in-1 Wireless Charger to a reliable wall adapter.
2. Charging a Phone: Place your Qi compatible phone atop the phone charging area to begin charging.
3. Charging a Watch: Place your iWatch atop the watching charging area to begin charging. It's recommended that the watch charger either be flat or at a 90 degree angle for optimal charging.
4. Charging Earbuds: Place your Qi compatible earbuds atop the earbud charging area to begin charging.

Precuations

1. Keep product dry to avoid short circuits or other damage to electronical components.
2. Avoid placing metal or magnetic items on the charging area which could result in overheating and product failure.
3. Keep device away from high heat and flammable liquids and gasses. Avoid using in environments above 45°C and below 0°C.
4. We strongly recommend using a high quality, certified wall adapter to provide power to this device. Failure to do so may result in slow charging speeds or product failure.
5. Do not disassemble the product or replace any parts. In case of the damage to this item, please stop using the product immediately.
