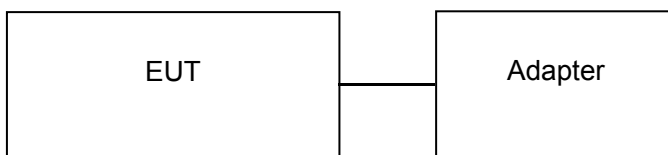

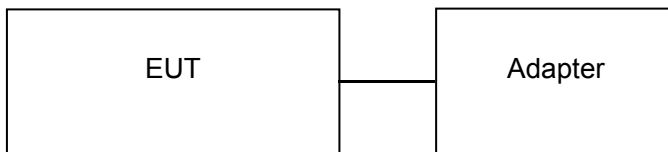

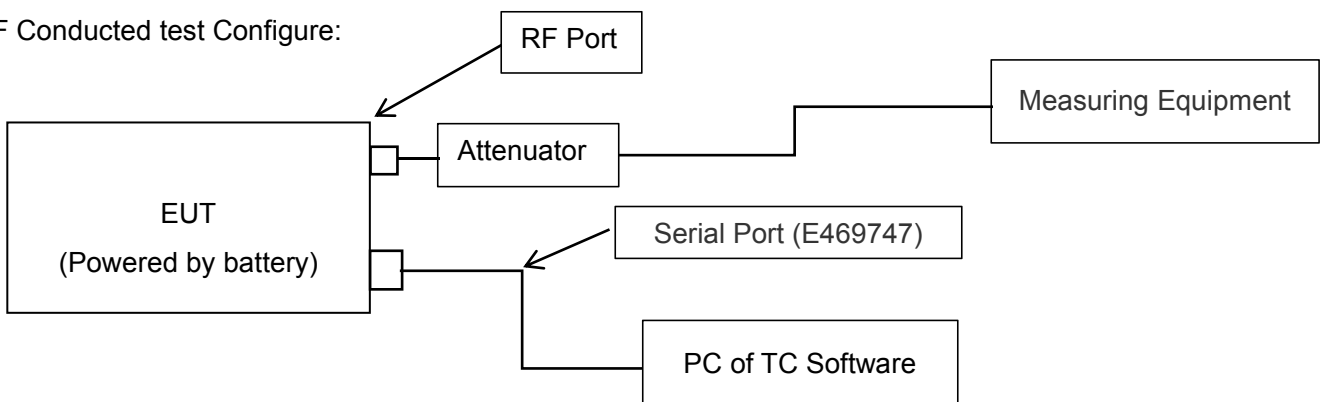
Radiated Emission Configure:

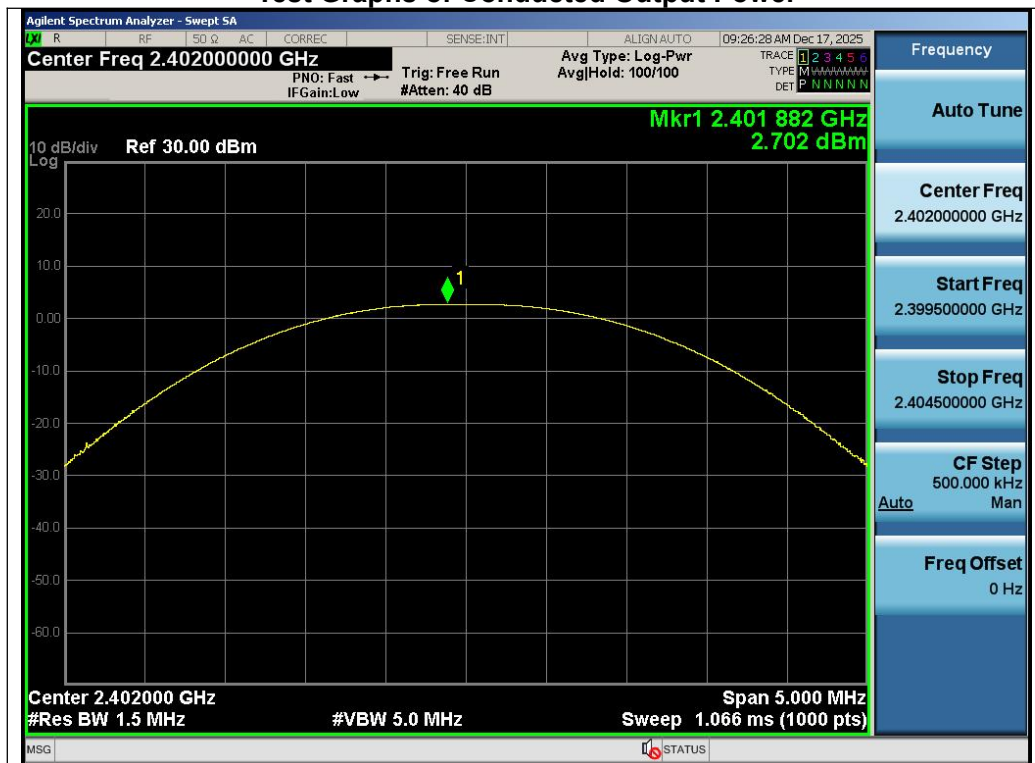

Test Graphs of Conducted Output Power

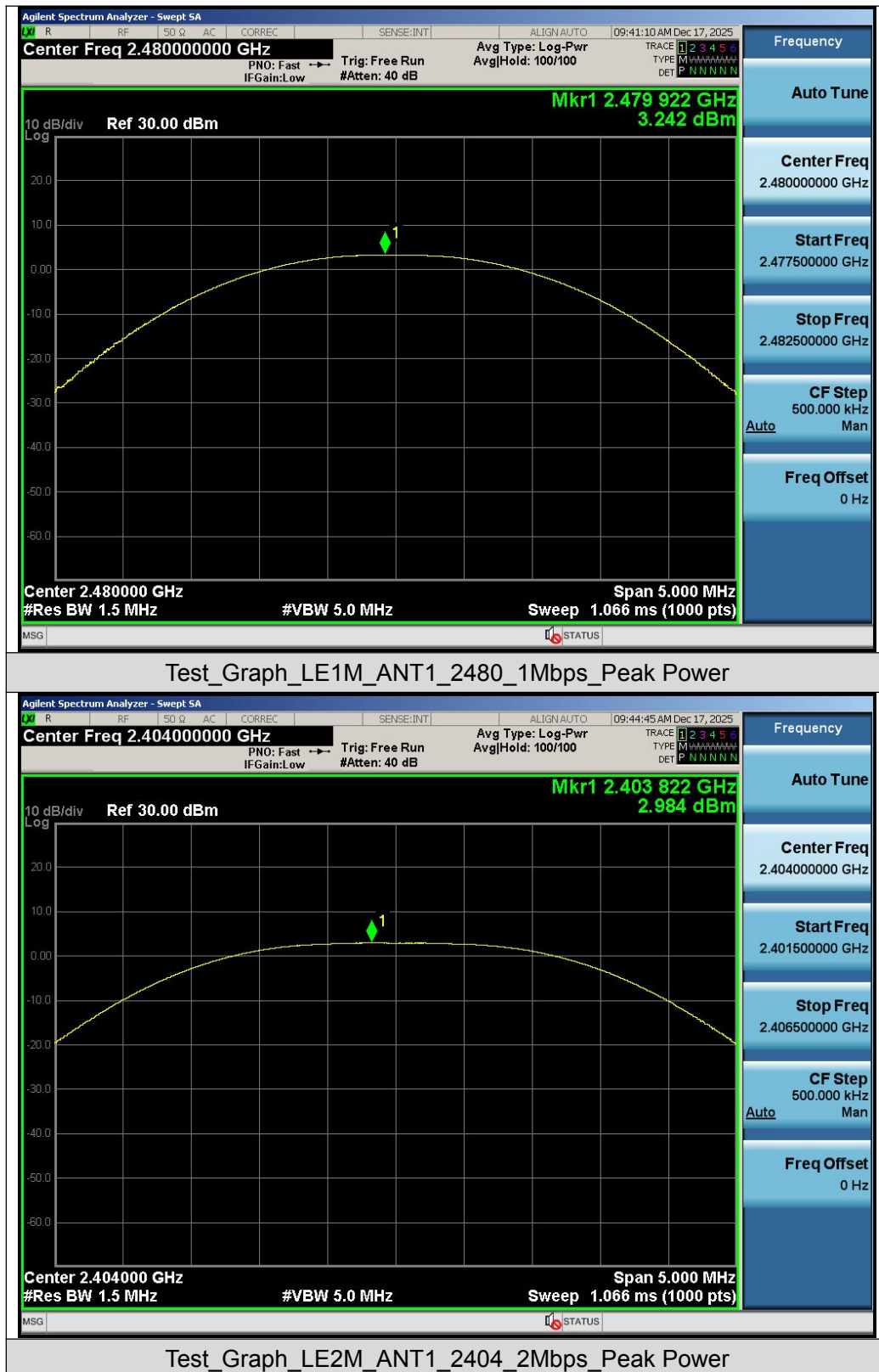


Test_Graph_LE1M_ANT1_2402_1Mbps_Peak Power



Test_Graph_LE1M_ANT1_2440_1Mbps_Peak Power

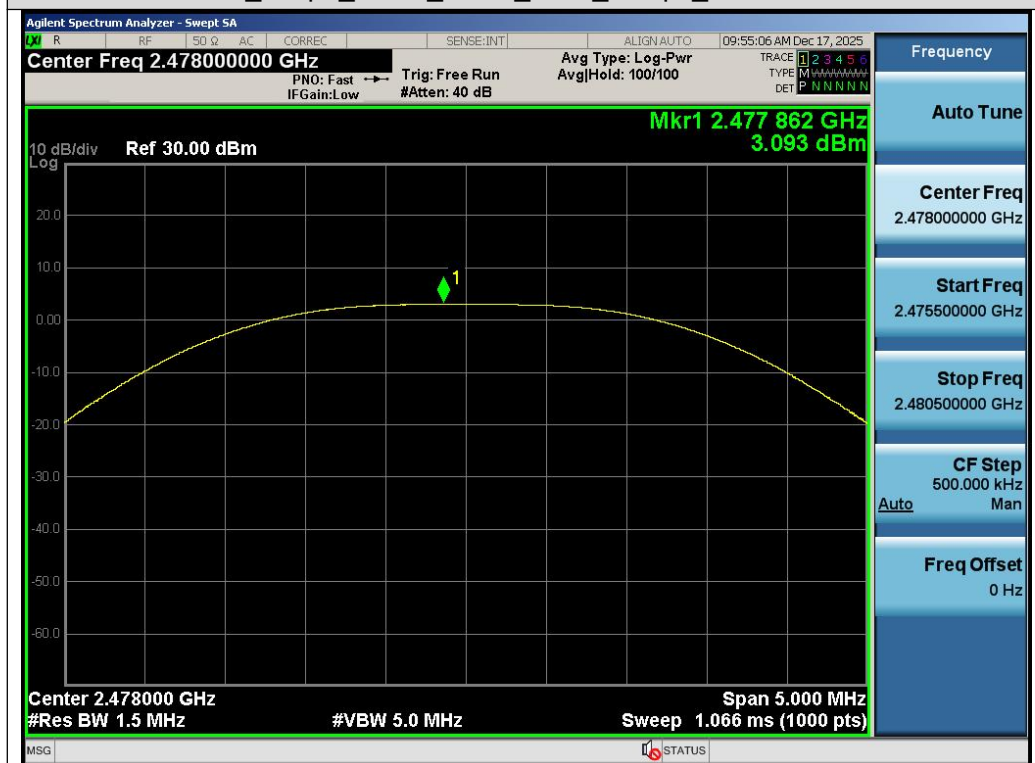

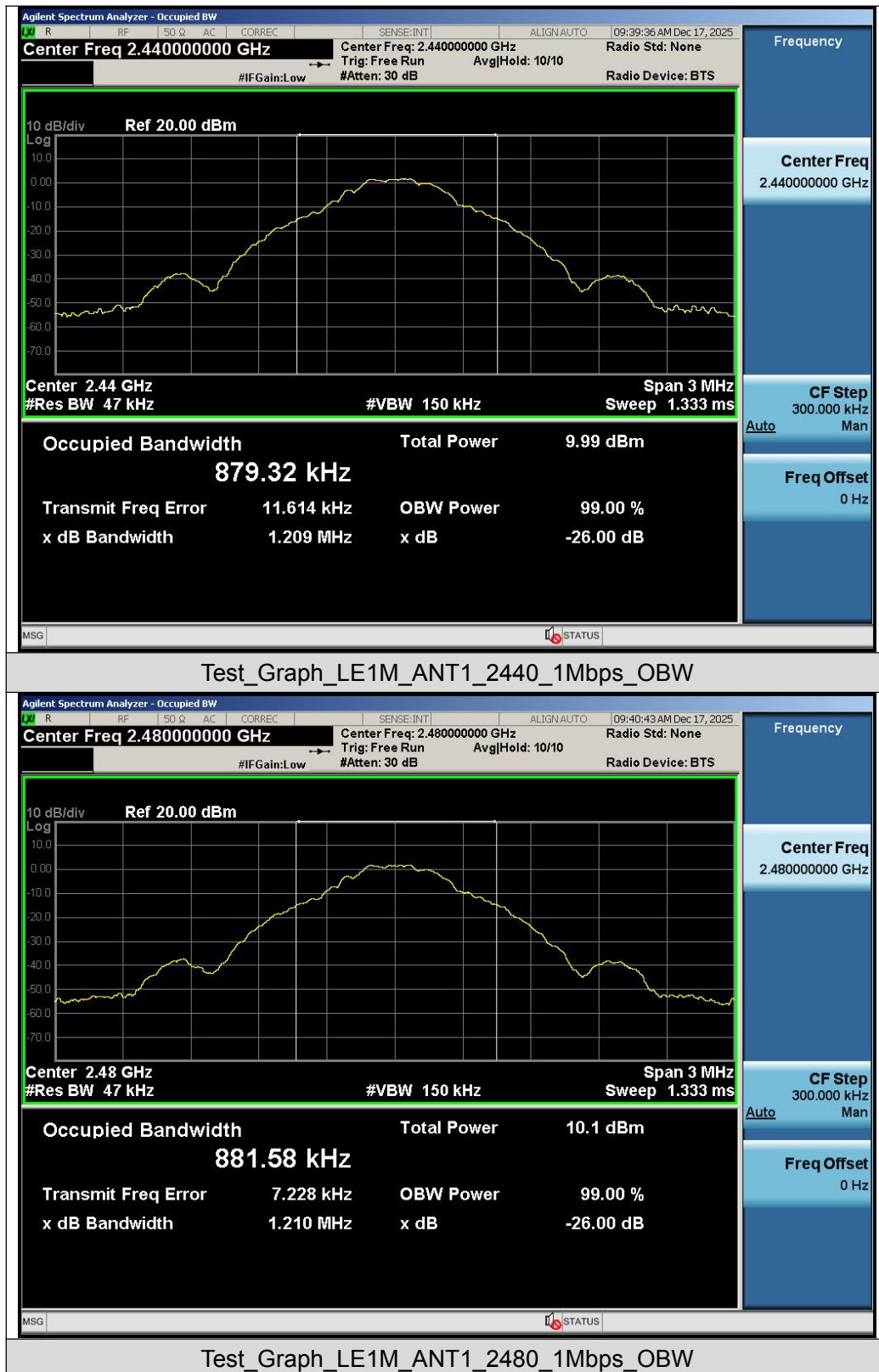

Test Graphs of Occupied Bandwidth



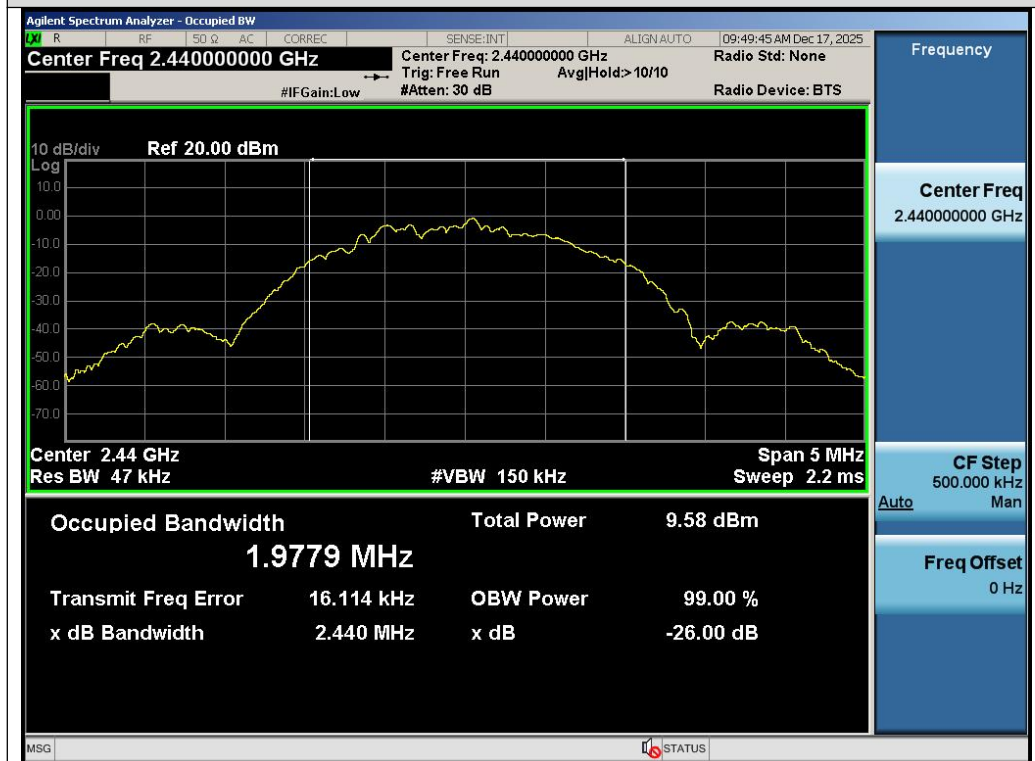

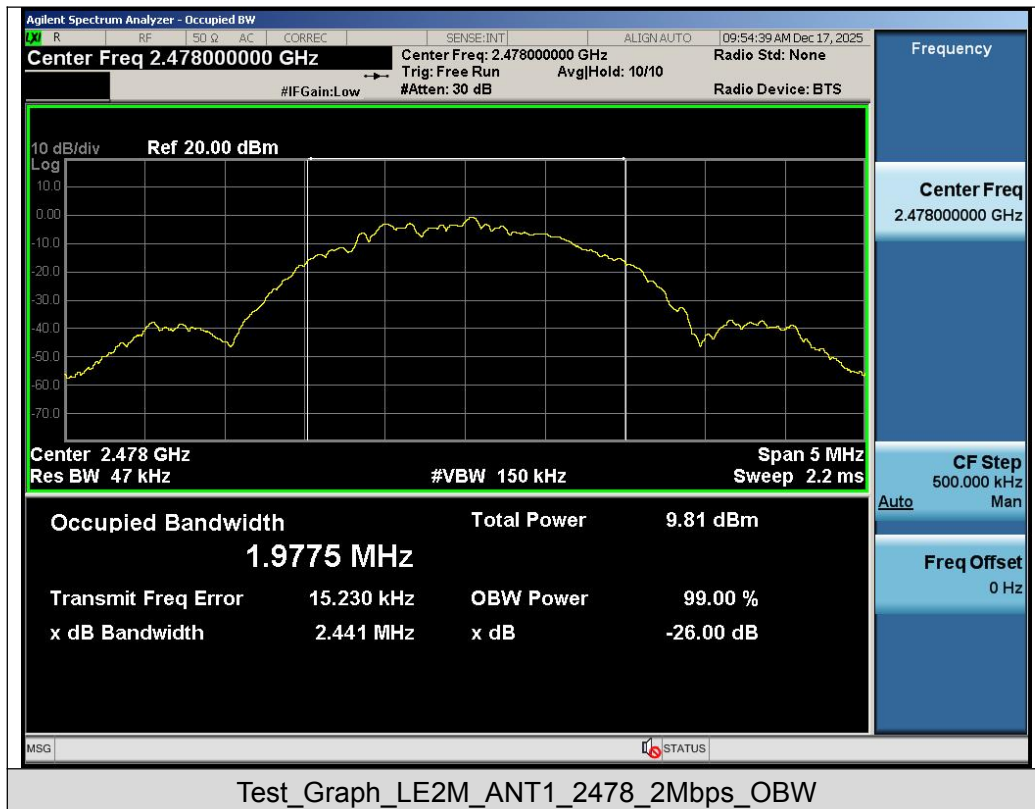


Test_Graph_LE2M_ANT1_2404_2Mbps_OBW

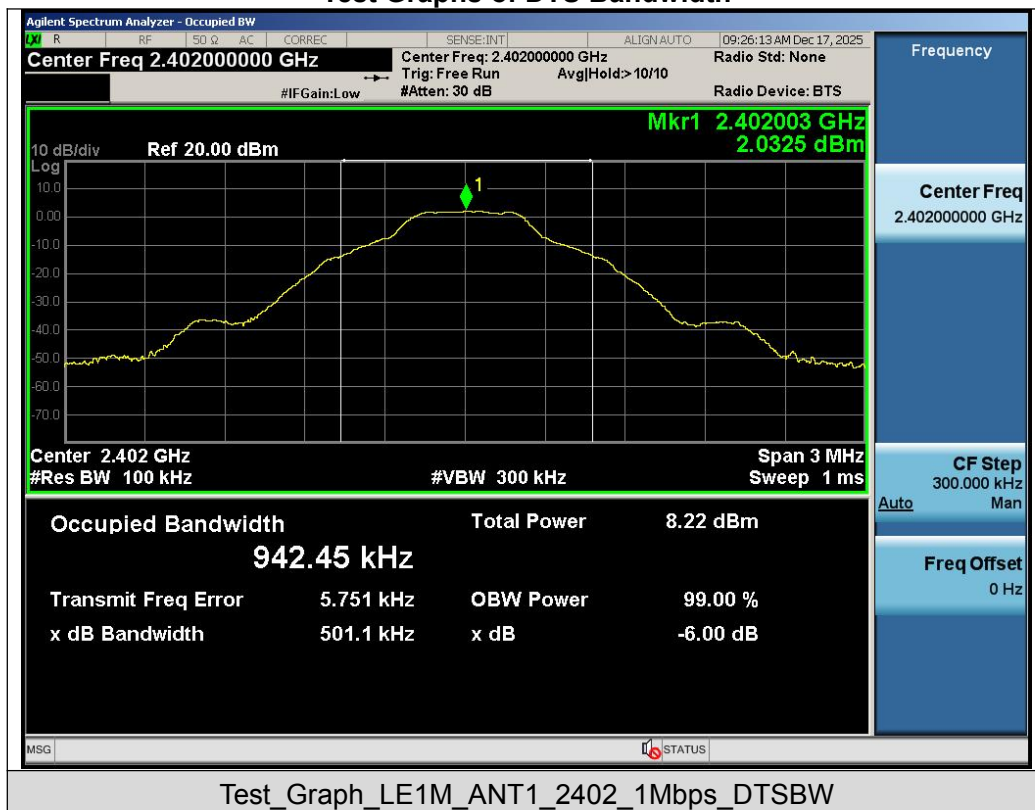

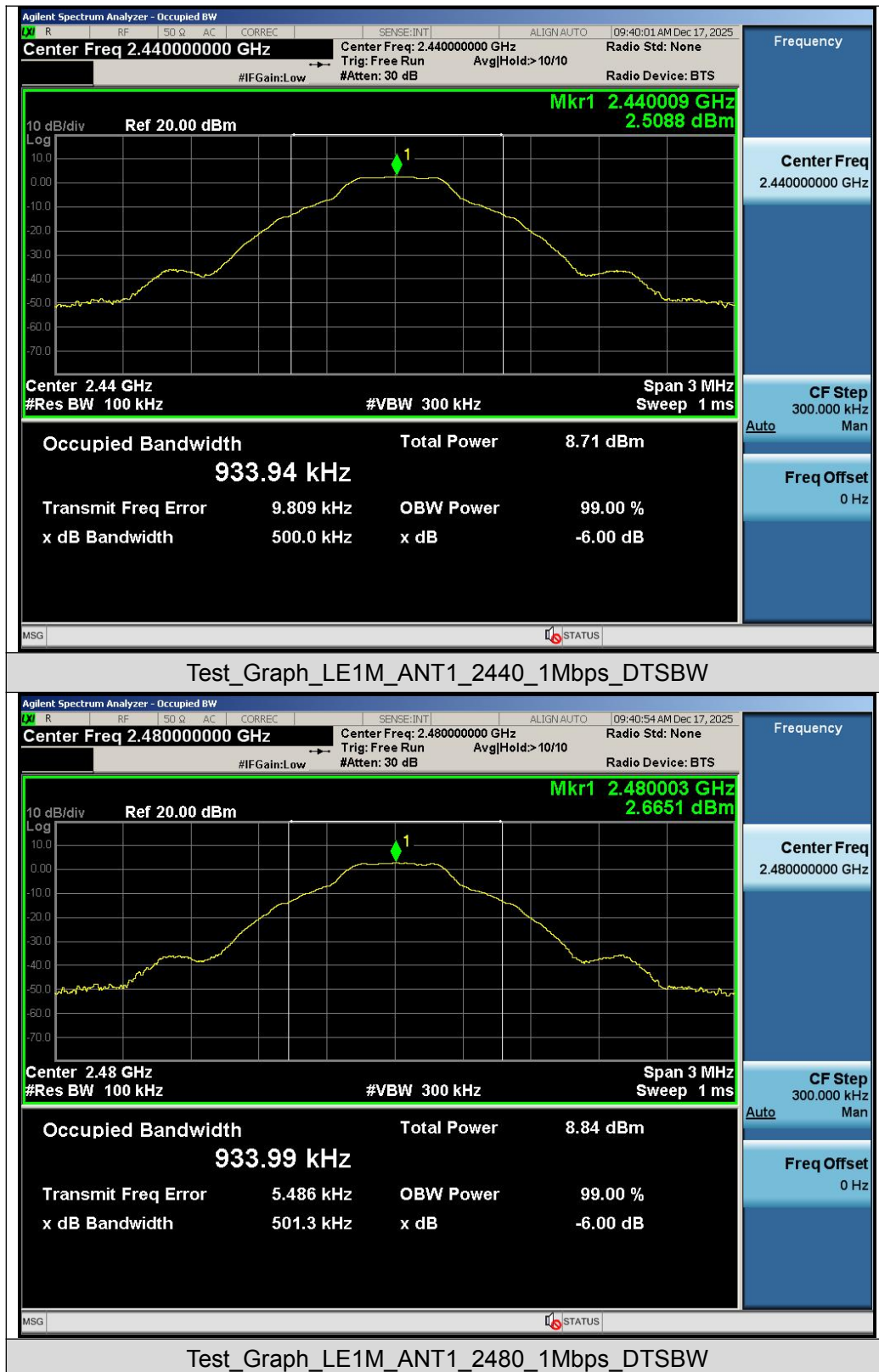

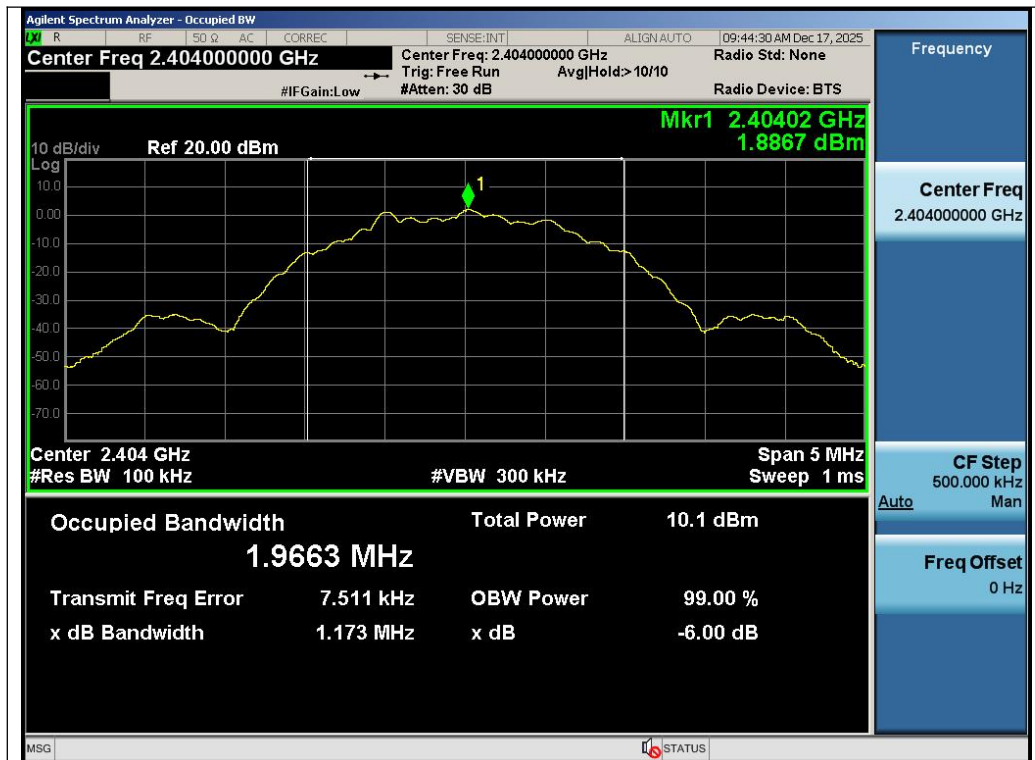
Test Graphs of DTS Bandwidth



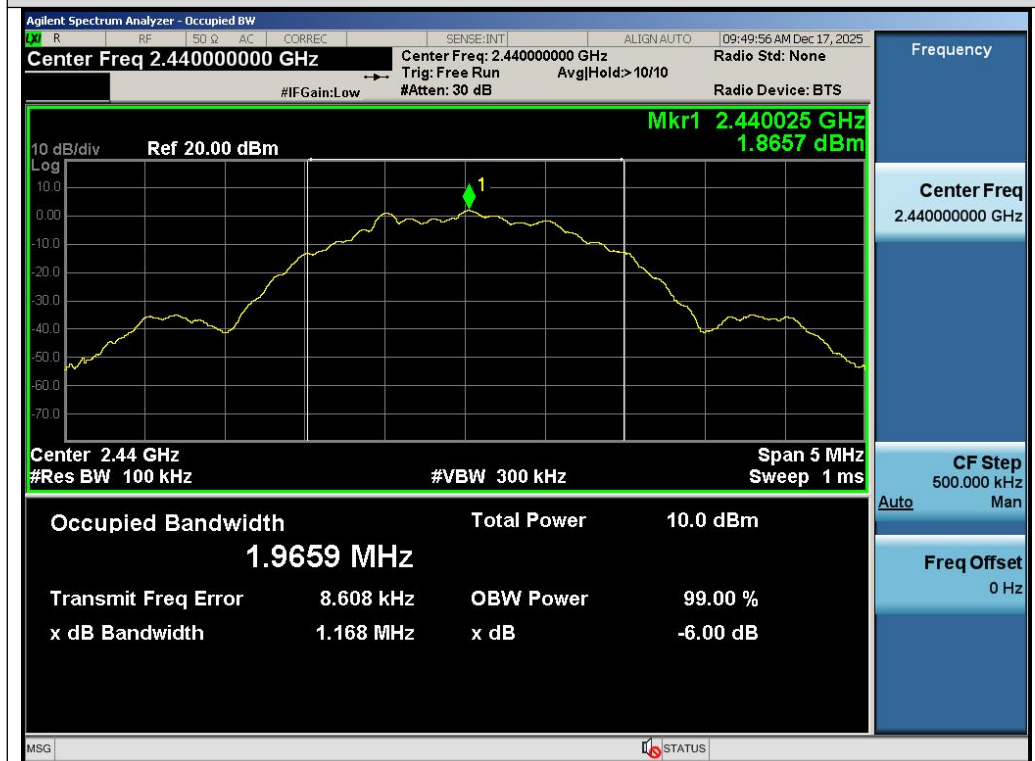

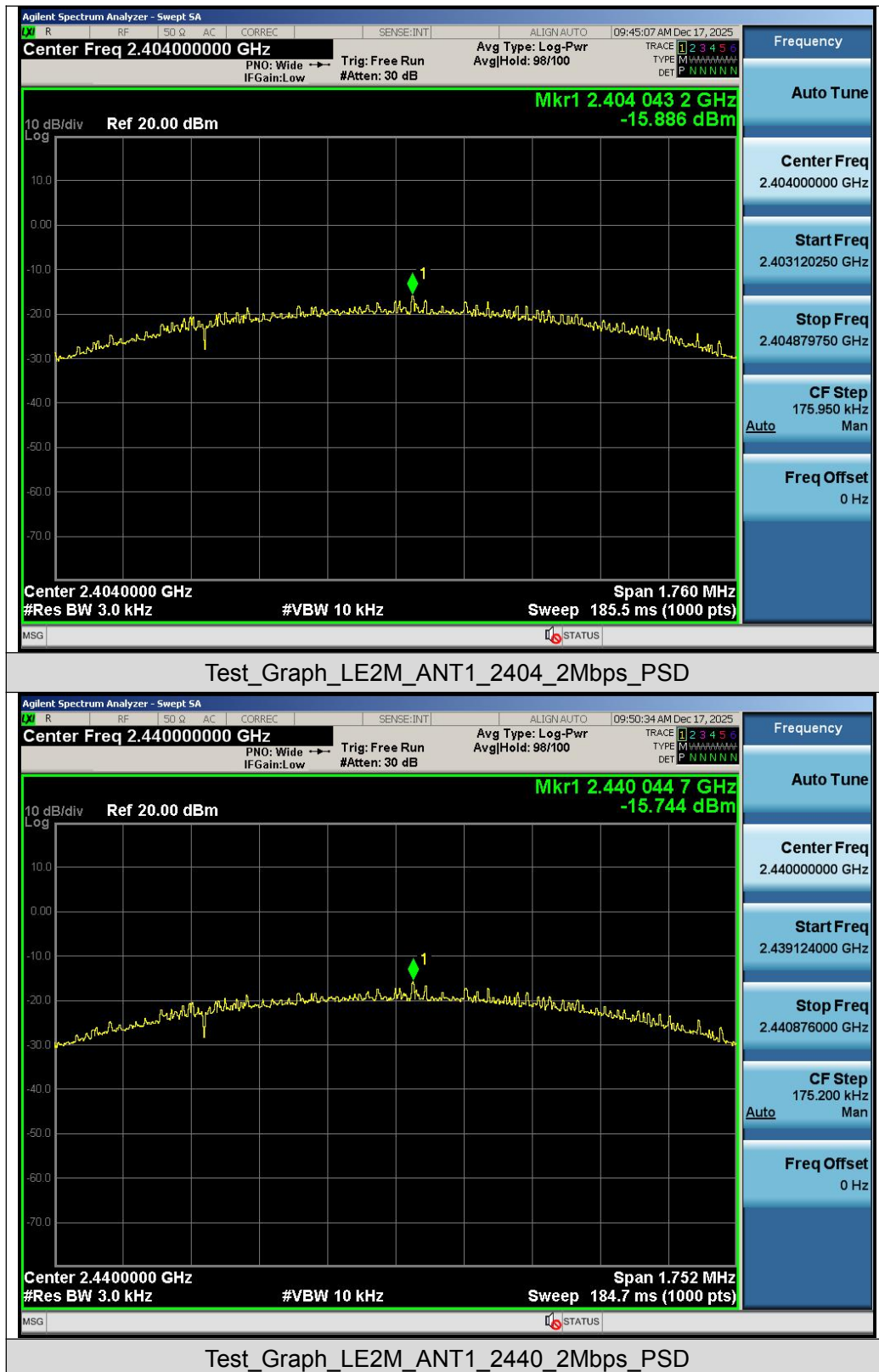
Test Graphs of Conducted Output Power Spectral Density



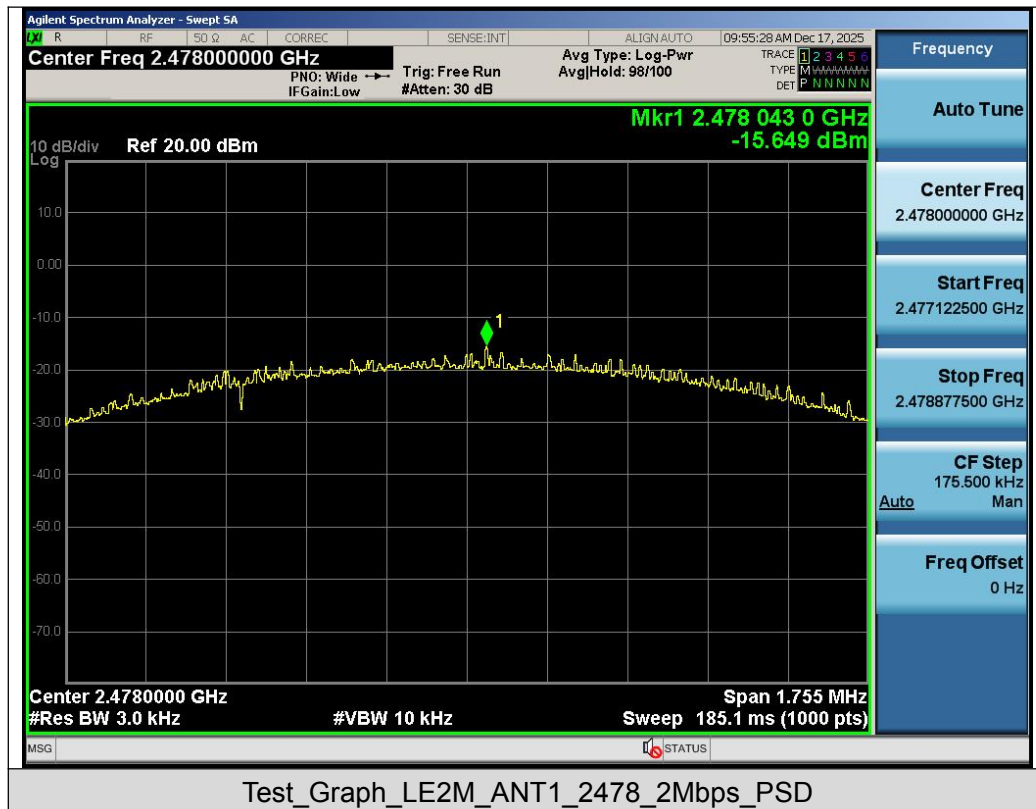

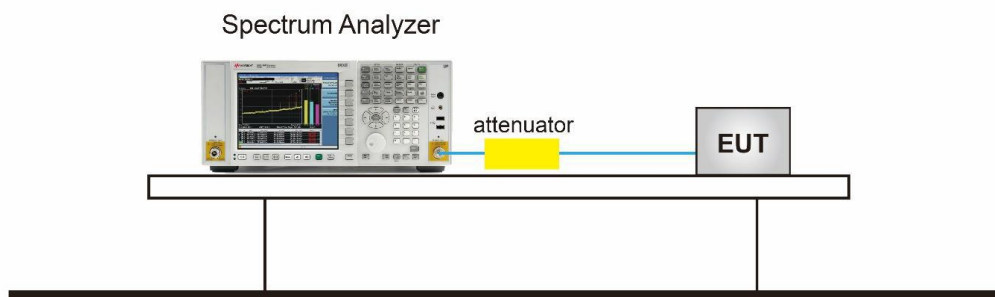

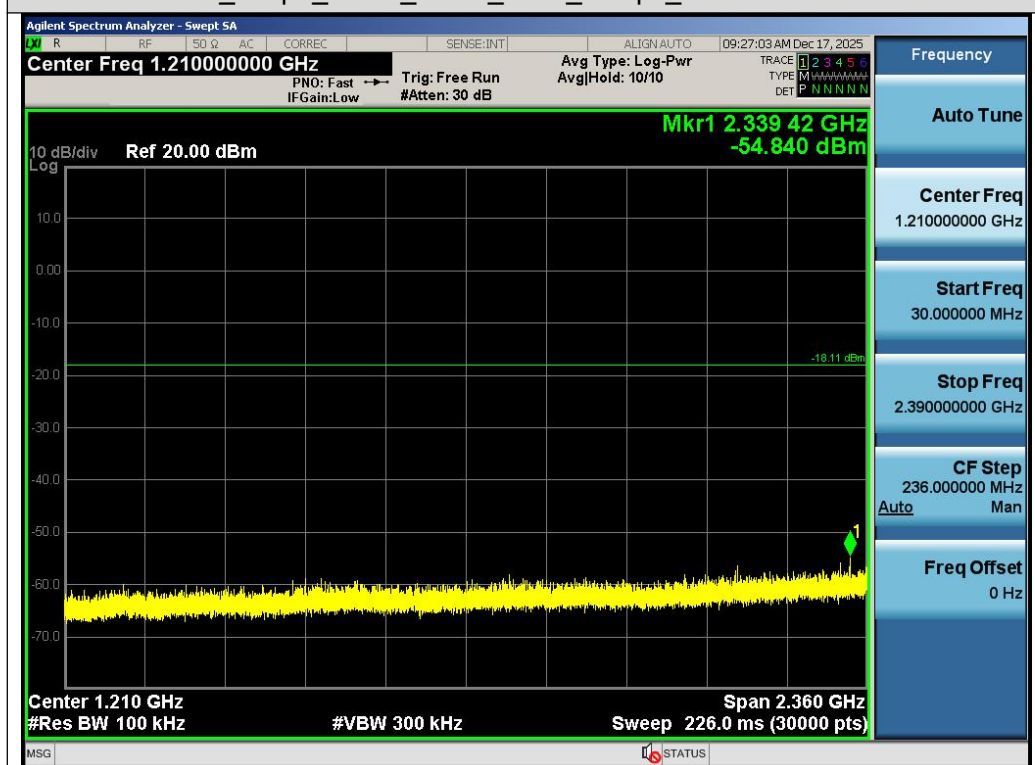

Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



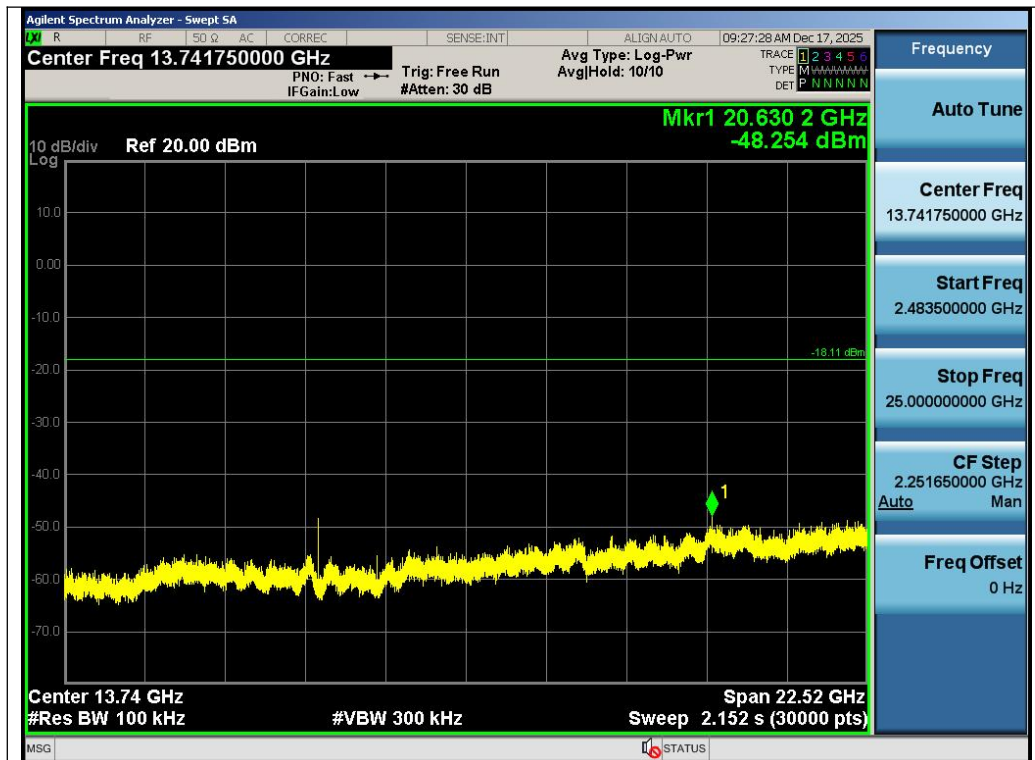

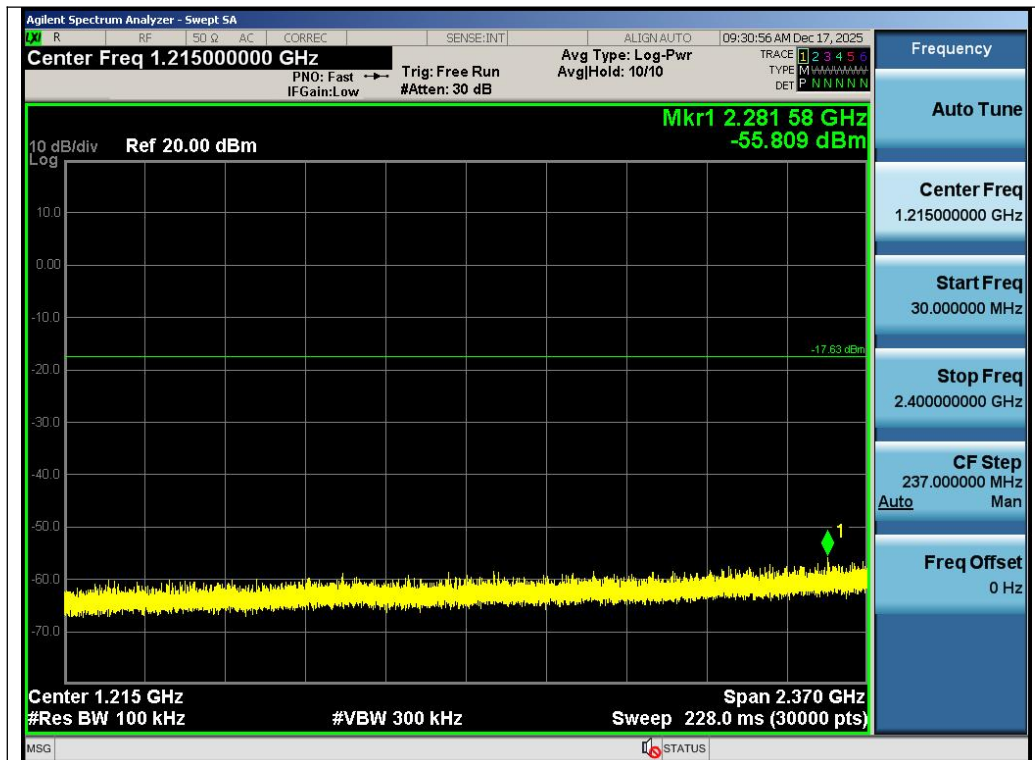


Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions

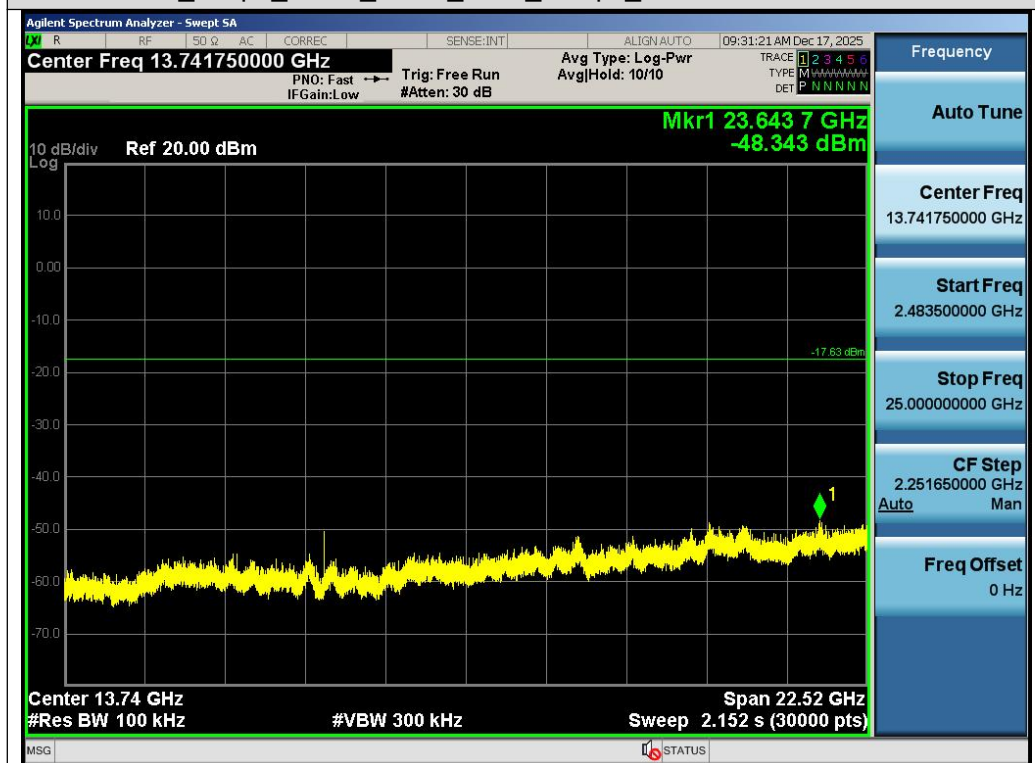

Test_Graph_LE1M_ANT1_2440_1Mbps_Lower Band Emissions

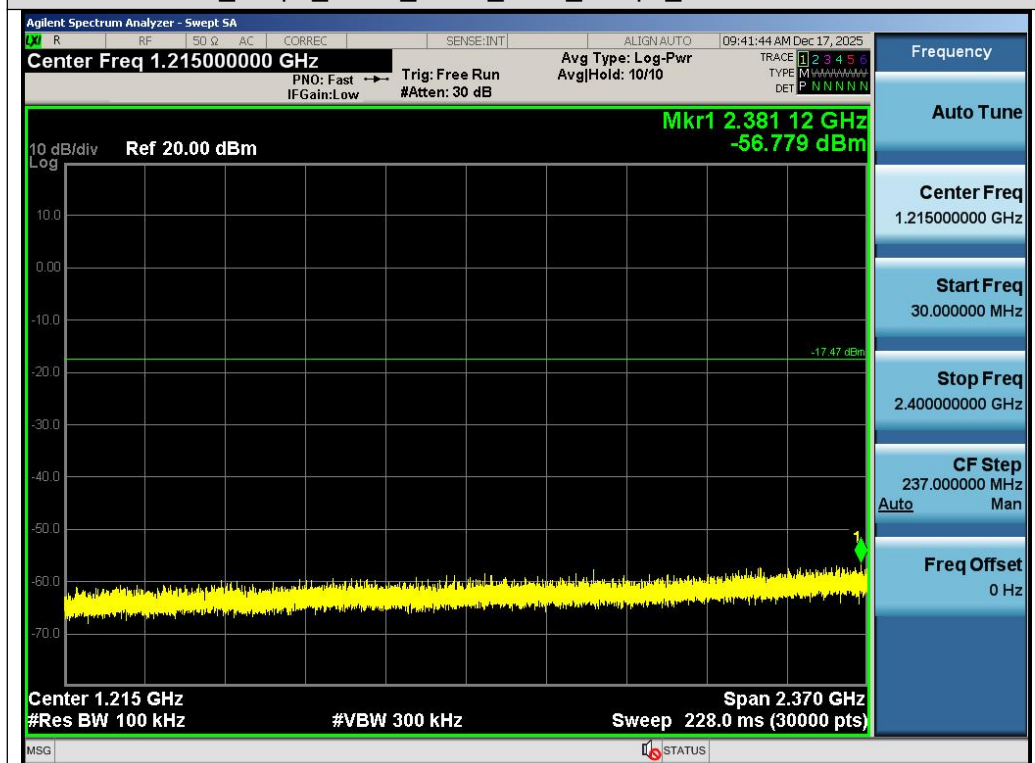

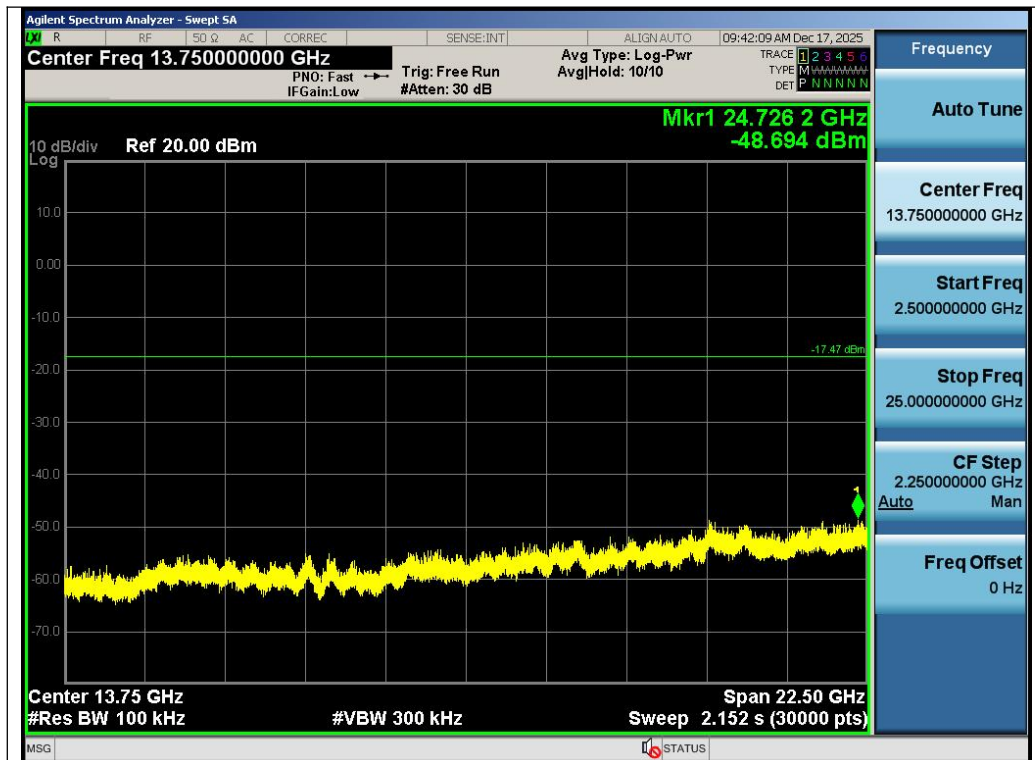

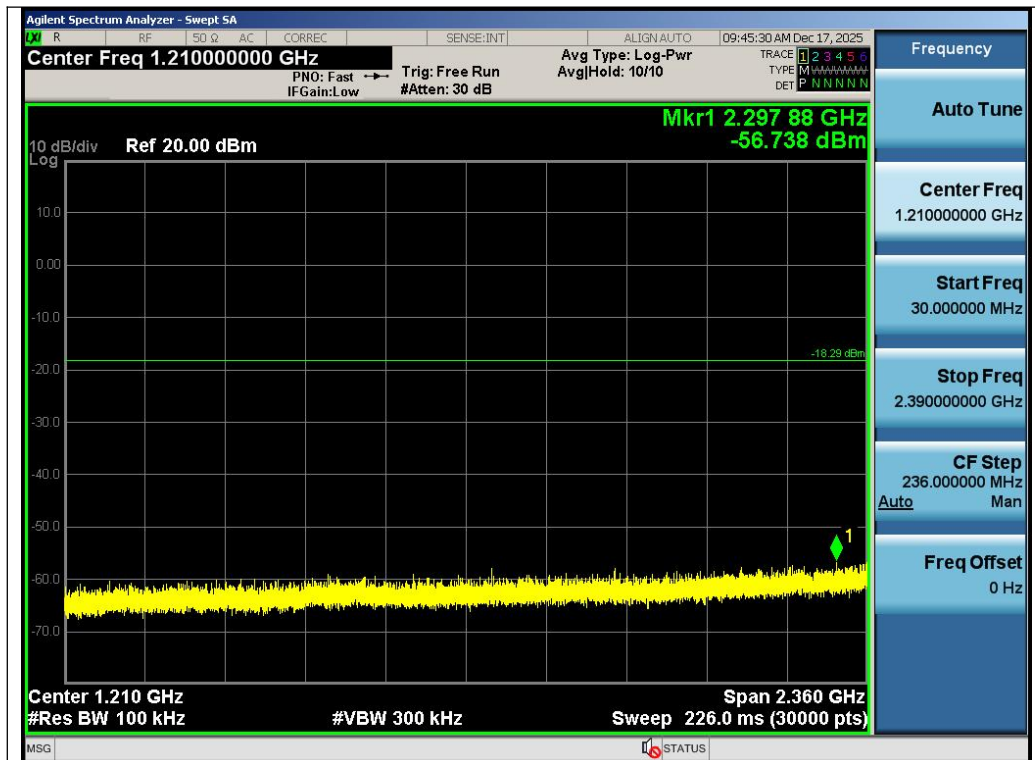


Test_Graph_LE1M_ANT1_2480_1Mbps_Higher Band Emissions
