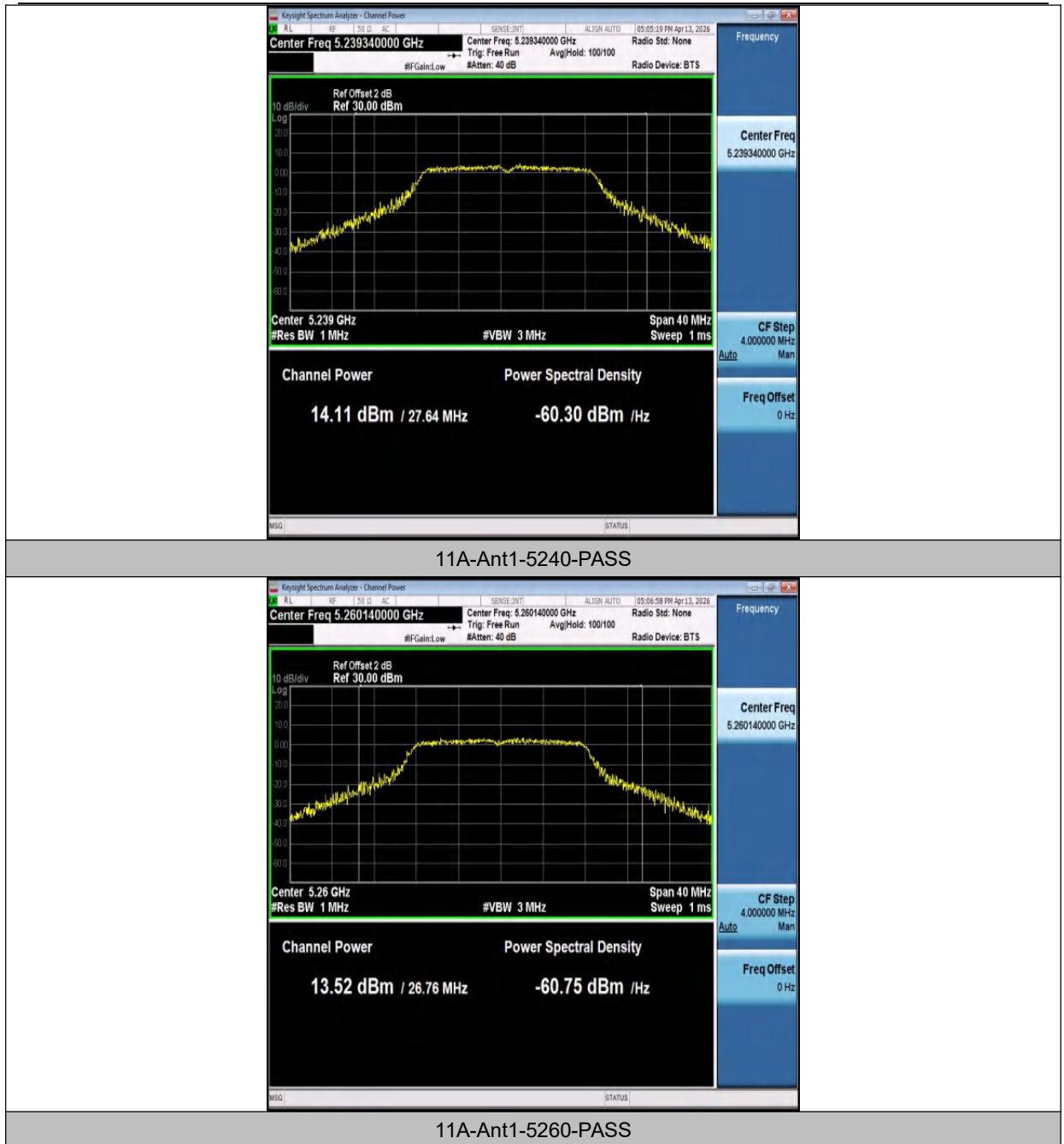
Test Graphs Channel Power
