如何正确安装耳机

1

将魔术贴粘贴到控制器和头盔上。

2

捏住背夹，将尖头插入控制器底部孔中。

3

使用背夹和魔术贴，将控制器固定到头盔上。

4

将耳机套件的魔术贴粘贴到头盔内侧的蓝牙耳机凹槽，以及头盔口附近的麦克风魔术贴。

5

将耳机套件和麦克风风连接到头盔上。电缆较短的喇叭适用于左耳。调整头盔内的电缆以获得舒适感。

6

将耳机套件连接到控制器，安装完成。

在您的设备上，打开蓝牙并选择连接到“HTC NE87”。

开机/关机

按下 3秒，开机/关机。
注：开机后，3分钟未与蓝牙设备配对连接，自动关机；超出有效连接距离，未与蓝牙设备连接，3分钟后自动关机。

• 音量减：点击 一次

• 上一曲：按 3秒

• 下一曲：按 3秒

• 通话接听/结束：点击 一次

How to install the headset

1

Attach the adhesive fasteners to the controller and the helmet.

2

Attach the clip to the bottom of the controller. Pinch the clip to insert the prongs into the holes.

3

Attach and secure the controller to the helmet using the clip and adhesive fasteners.

4

Attach the adhesive fasteners for the speakers to the Bluetooth headset grooves inside of the helmet as well as the fastener for the microphone near the helmet mouth.

5

Attach the headset speakers and the microphone to the helmet. The speaker with the shorter cable is for the left ear. Adjust the cables inside the helmet for comfort.

6

Connect the headset to the controller.

Connect to Bluetooth device

On your device, turn on Bluetooth and choose to connect to "HTC NE87".

Basic operations

Power on/off

Press and hold for three seconds.
Note: The device will power off automatically if it is not paired with Bluetooth for more than five minutes or is out of range.

Key functions

• Play/Pause: Press

• Reject call: Press and hold for two seconds.

• Activate voice assistant: Press

• FM mode: Press and hold for two seconds.

• Switch stations: Press

• Scan for stations forward: Press and hold

• Scan for stations backward: Press and hold

• Turn on/off ambient light: Press three times.
