TR686 remote control



←Press to turn on vibration / Long press to turn off vibration; Press to switch frequencies; The button light stays on when the device is activated, and flashes once with each press.

←Long press to turn on/off the power; Press to activate/deactivate the function; After power-on, both functions are set to the maximum frequency by default, and the button light stays on when the device is activated.

←Press to turn on telescoping / Long press to turn off telescoping; Press to switch frequencies; The button light stays on when activated, and flashes once with each press.

If no action is taken after 10 minutes, the device will shut down automatically.
