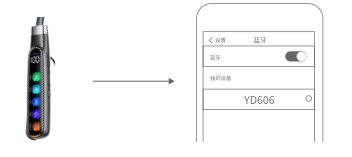

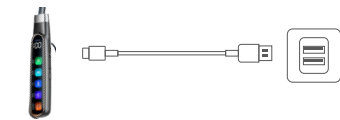
1.开机

当耳机处于关机状态时，长按开机键3秒，打开智能设备的蓝牙列表，搜索“YD606”并连接。
注:若耳机5分钟内未与相应蓝牙设备进行配对成功，便会自动关机。

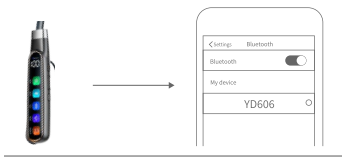

Product Operation Instructions

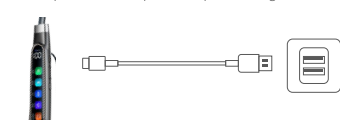
1. Power On
When the headphones are powered off, press and hold the O button for 3 seconds, and the headphones will prompt "Power On"
2. Power Off
When the headphones are powered on, press and hold the O button for 3 seconds, and the headphones will prompt "Power Off"
3. Pairing
When the headphones are powered off, press and hold the power button for 3 seconds, open the Bluetooth list on your smart device, search for "YD606" and connect.
Note: If the headphones do not successfully pair with the corresponding Bluetooth device within 5 minutes, they will automatically power off.



Power Button:
Long press for 3 seconds: (Power on/off)
Music Mode: Single click: Pause/Play Triple click: Switch TF/Bluetooth call mode
Call Mode: Single click: Answer call Double click: Redial Long press for 2 seconds: Reject call
Volume +/- Button: Single click: Volume up Long press: Next track
Single click: Volume down Long press: Previous track
M Button:
In music mode: Single click: Switch sound effect mode Double click: Switch ear return

Long press for 2 seconds: Enter voice assistant

Charge the headphones

When the headphone battery is low, the headphone will emit a prompt sound 'beep beep' and announce it every 60 seconds until it shuts down. At this time, connect the charging cable to the headphone and a 5V power adapter to charge.
